The unit covers EMS for 9 communities primaryly and mutual aid for another 7 communities. The unit covers part 139 coverage for airline operations, provides fire coverage for the city of Presque Isle as well as mutual aid for surrounding communities. The current CBA consist of 25 members to include; (1) Daytime Deputy Chief, (4) Captains, and (20) Firefighter/Paramedics/AEMT/EMT.
