# MAINE PUBLIC UTILITIES COMMISSION

## FILING INSTRUCTIONS FOR ANNUAL COMPETITIVE ELECTRICITY PROVIDER REPORTS – REPORTING YEAR 2024

The Commission uses an electronic Case Management System (CMS) for all filings, including the annual Competitive Electricity Provider (CEP) reports. **CEP annual reports must be submitted by July 1, 2025.** Please electronically file the completed original Excel document in CMS (do not mail a paper copy, do not electronically file a .PDF).

Please follow the following four easy steps to file your annual report:

- 1) Complete the Excel report and save on your computer
- 2) Register to use our CMS system (see p. 2)
- 3) Login to CMS<sup>1</sup>
- 4) Upload your information
  - a. General Information for all CEPs, see page 3
  - b. If providing confidential information, choose from Option i or Option ii:
    - A protective order has been issued in Docket No. 2025-00024 allowing for confidential treatment of the following portions of the Excel report template: Summary tab, responses to question 6 on tab 2, responses to questions 9,16 and 19 on tab 3, tabs 4 through 7, and tabs A through C.
       Please note that the aggregate totals for Maine are not granted confidential treatment. Question 5 on Tab 2 of the report for CEPs providing aggregator/broker services is also allowed confidential treatment.
    - ii. If additional information needs to be kept confidential
      - 1. File a request for a protective order in Docket No. 2025-00024 *no later than June 1, 2025.*
      - 2. Wait until the protective orders have been issued.
      - 3. THEN file confidential information, see instructions on P. 4 Confidential Report MUST be filed in Excel, and the public report may be filed in Excel *OR*.PDF format

If you file the data before receiving the protective order or do not associate the filing with the protective order, it will NOT be confidential.

#### Registration

To file the CEP annual report in CMS, the person actually submitting the report must become a registered user in our system.

You may register at:

- Fill in all required fields
- After submitting your registration, you will receive an email notification with a hyperlink and instructions.

If you do not receive this email, please check your junk mail for an email from MPUC-CMSnotification@maine.gov.

- Go to the hyperlinked page and confirm your registration.
- You are now registered to submit documents into CMS.

Pointers:

- User IDs must be at least 8 characters long and cannot have spaces
- Passwords must be at least 8 characters long and must include numbers, at least one upper case letter, and at least one special character
- The first Company/Organization field is the company you work for for example ABC Consulting, which may not be the company you represent for PUC purposes
- The Representing Company/Organization field is for the company for which you are submitting an annual report. To populate your profile with the company or companies that you represent, click the "Add" hyperlink. CEPs are listed as Utility/Industry Type: Electricity and Utility/Industry Subtype: Competitive Electricity Provider. Your entity should be on this listing and will be available to choose from.
- You may add more than one company or organization. You may return to the screen in the future to add more companies/organizations or to remove them.

#### Submitting CEP Annual Report

## (PLEASE NOTE THAT YOU SHOULD NOT START THIS PROCESS UNTIL YOU HAVE COMPLETED THE FULL REPORT AND SAVED IT ON YOUR COMPUTER)

- Log into CMS (<u>https://www.maine.gov/mpuc/online/index.shtml</u>)
- Once logged in, hover the cursor over "Annual Report File" in the menu on the left side of the screen; click on "Submit Annual Report"
- For "Utility Type", choose "Electric".
- For "Utility Subtype", choose "CEPs". (Note: once this selection is made, "Annual Report Type" will automatically select the appropriate report type.)
- For "Pertaining to Utility/Company", select your company's name.
- If the regulatory contact information from the records in the system is incorrect, please contact the Commission at <u>maine.puc@maine.gov</u> with the updated information
- For "Report for Year", enter the year for which you are filing the report. (for the report you file in 2025, enter "2024" in this field.)
- For "Name of Person Completing Annual Report", enter your name.
- Click on "Verify Contact Information of Person Completing this Annual Report" to verify that the contact information is correct a pop-up window will open.
  - o is it correct? Click "confirm";
  - Is it wrong? Correct the information as necessary and click "update".
- Docket Number Granting License docket numbers are used in lieu of a license number – The docket number format is YYYY-00000 – for example, if your docket number was 1999-1, you would insert 1999-00001. See below for tips on how to find your initial licensing docket number.
- For "Is Company", use the radio buttons to select whether your Company is "an Aggregator/Broker" or "a Supplier"

-- if you are licensed as both, select "a Supplier"

- Click "Submit"
- Click "OK" to confirm submission you will receive the following message:

 Click "Attach Report Now" to proceed to next screen to attach your completed report – upload the completed Excel workbook.

CEP Annual Report Filing Instructions: 4/2025

### Filing Annual Report(s)

The radio button at the bottom of the page will allow you to upload either public or confidential versions of your annual report.

#### If you are filing a confidential document of your annual report:

At bottom of the page, click the "Confidential" radio button, then click button that says "Attach Confidential Document".

- A second window will open to allow you to Browse your computer for the electronic copy of the annual report -- click "Attach"
- For confidential documents, you **must** attach a redacted copy (Excel or pdf) as well as the confidential version (Excel) -- you will also be required to associate the proper protective order.
- Click "Submit"

The confidential report *MUST* be the active Excel workbook. You may post a .pdf version of the redacted information if you would prefer, but the confidential version *must* be the active Excel Workbook.

Protective Order No. 1 has been issued in Docket No. 2025-00024 for the Summary tab, response to question 6 on tab 2, responses to questions 9,16 and 19 on tab 3, tabs 4 through 7, and tabs A through C. If you want additional information to be kept confidential, you must file a request for a protective order in Docket No. 2025-00024 and additional protective orders will be issued when appropriate. Question 5 on Tab 2 of the Aggregator/Broker report shall also be considered confidential.

Do not file any confidential information until the Protective Order is issued. **DO NOT FILE THE REQUEST FOR PROTECTIVE TREATMENT IN THE ANNUAL REPORT MODULE.** Instead, file it in Docket No. 2025-00024.

If you have chosen to complete the key analysis fields and those fields contain confidential information, click the box before the statement "This data includes confidential information pursuant to the Commission issued Protective Order"

#### If you are filing a public document of your annual report:

At bottom of the page, click the "Public" radio button, then click the "Attach Document" button

- A second window will open to allow you to Browse your computer for the electronic copy of the annual report -- click "Attach"
- You must attach the Excel version of your report
- Click "Submit"

#### Finding your Docket Number Granting License

- After logging into CMS, hover over "Case File" and select "View/Search"
- Using the dropdown menu besides 'Pertaining To Utility/Company" search for your CEP name
- Click "Search" this will bring up a list of all cases in CMS related to your CEP the first case should be your original licensing docket

## A. <u>Troubleshooting</u>

- Check that your browser allows pop-ups from <a href="https://mpuc-cms.maine.gov">https://mpuc-cms.maine.gov</a>
- In some cases, a small window will open behind the larger browser window if you
  click on "Attach document" and nothing seems to happen, minimize the larger
  screen or look to the bottom of your screen to see if there is another window opened
- If the utility company is not on the list from which you may choose, check your profile to ensure that you have included that Company as one you are representing
- If you exit prior to attaching the files, when you return to complete the filing, please select "Revise Annual Report" from the Annual Report menu in CMS, to attach the report files
