

2018 Goal: \$505,000

2018 MSECCA Campaign Incentives and Goals

MSECCA's overall campaign goal is \$505,000. (This is below the nearly \$566,000 raised in 2017 since we didn't include the \$60,000 in Hurricane Relief donations.) In order to qualify for any incentive, MSECCA's \$505,000 goal must ultimately be reached.

Incentive One - Monday, December 24th Off:

If this overall goal of \$505,000 is met PLUS your department has met its own goal, you'll get Monday, Dec 24th off with pay.

Incentive Two - Wednesday, December 26th Off:

If the overall campaign goal of \$505,000 has been reached AND if your department has raised 120 % of the department goal, you will also get Wednesday, December 26th off with pay. Once the goal of \$505,000 has been reached, departments that exceed their department goal by 20% will get two days off with pay – both Monday, December 24th and Wednesday, December 26th.

Incentive Three - Drawing for an All-Expense Paid Trip to Jamaica!

All departments having 100% employee participation with a minimum donation of \$52 each, will enter their employees' names for a statewide drawing. The winning employee and a guest will have an all-expense (air, hotel and food) paid vacation to Jamaica!

Deadline to Qualify for Incentives - Wednesday, December 12th:

The overall campaign goal can be reached before or after the department goal. However, the cutoff for determining which departments qualify for the incentives is Wednesday, December 12th. This allows your payroll department adequate time to process payroll deductions. Though cash/credit card contributions can be made after the 12th, they will not count toward the incentives.

Good luck but please keep in mind the purpose of the campaign is to raise money for our friends and neighbors in need as well as for the many nonprofits that are counting on our support.
