**SUBJECT: General Salary Increase** 

**DATE:** June20, 2005

TO: All Departments and Agencies

FROM: Edward A. Karass, State Controller

MSEA, MSTA, and AFSCME have a general salary increase effective July 3, 2005. The Law Enforcement Unit's increased is still being negotiated, therefore will not be automatically updated at this time.

All employees are eligible to receive a 3% general increase unless a fixed salary is set by statute. Some employees' salaries are set by or subject to the approval of the Governor or a Board or Commission. Specific approval from the salary setting authority must be obtained for all such employees as prescribed by Law before a general increase can be authorized.

The general increase will be applied automatically to employees for whom eligibility and amount of increase can be determined through electronic means.

Saturday, July 9th – New rates will be loaded in Master file records for Cycle B employees.

July 20 - Cycle A - Pay Date contains 3% increase. (Split)

July 27 - Cycle B - Pay Date contains 3% increase.
