SUBJECT: Federal Funding Accountability and Transparency Act Reporting (FFATA) – Guidance

The purpose of this memorandum is to remind State agencies that Transparency Act (FFATA) reporting is a current federal requirement. See Public Laws 109-282 and 110-252 FFATA Legislation. This memorandum also serves as a continuation of Controller's Bulletin FY11-02.

The Transparency Act requires reporting of first-tier subawards related to an agency's Federal grants, cooperative agreements, loans and other forms of Federal financial assistance (non-ARRA) and executive compensation of awardees. The information provided in this FY 2013 bulletin relates primarily to Federal grants although similar requirements are in place for Federal contracts. Frequently Asked Questions (FAQs)

Q. What does Federal financial assistance subject to the Transparency Act mean? 2 CFR §170.320: "...assistance that non-Federal entities receive or administer in the form of grants; cooperative agreements; loans; loan guarantees; subsidies; insurance; food commodities; direct appropriations; assessed and voluntary contributions; and, other financial assistance transactions that authorize the non-Federal entities expenditure of Federal funds. Does not include technical assistance, which provides services in lieu of money; a transfer of title to Federally owned property in lieu of money, even if the award is called a grant; any classified award; or any award funded in whole or in part with Recovery funds, as defined in section 1512 of the American Recovery and Reinvestment Act of 2009 (Pub. L. 111-5)." For additional exceptions, see 2 CFR §170.110 (b). http://www.ecfr.gov

Q. What is a subaward?

2 CFR §170 Appendix A (e3 (i, ii, iii)): "This term means a legal instrument to provide support for the performance of any portion of the substantive project or program for which you received this award and that you as the recipient award to an eligible subrecipient. The term does not include your procurement of property and services needed to carry out the project or program. A subaward may be provided through any legal agreement, including an agreement that you or a subrecipient considers a contract."

Q. What is a subrecipient?

2 CFR §170 Appendix A (e4 (i, ii)): "...an entity that receives a subaward from you (the recipient) under this award; and is accountable to you for the use of the Federal funds provided by the subaward." Q. What is required to be reported?

2 CFR §170 Appendix A (I): "Reporting Subawards and Executive Compensation - Reporting of first-tier subawards - Applicability - Unless you are exempt (see, <u>2 CFR §170 Appendix A-d</u>), you must report each action that obligates \$25,000 or more in Federal funds that does not include Recovery Funds for a subaward to an entity."

2 CFR Section 170 Appendix A (3): "Report the information about each obligating action that the submission instructions posted at http://www.fsrs.gov specify"

2 CFR §170 Appendix A-d: "Exemptions – If, in the previous tax year, you had gross income, from all sources, under \$300,000, you are exempt from the requirements to report Subawards and the total compensation of the five most highly compensated executives of any subrecipient."

Q. Where and when do we report?

2 CFR Section 170 Appendix A (2): "Each obligating action is to be reported to http://www.fsrs.gov. For subaward information, report no later than the end of the month following the month in which the obligation was made."

Q. What is an obligation?

2 CFR §215.2 (t): "The amounts of orders placed, contracts and grants awarded, services received and similar transactions during a given period that require payment by the recipient during the same or future period." Funds need not be encumbered to be considered obligated.
