Summary: Impaired Driving Specialists, LLC will be teaching NHTSA's "DWI Detection & Standard Field Sobriety Testing" student course. In this interactive training, participants will learn about the concepts and principles of OUI detection and SFSTs, how to properly conduct SFSTs, and trial techniques in OUI cases.

Admission Restrictions: To attend this training, you must be eligible to accept PDS case assignments and be selected to attend. This training is by invitation only. Applicants must commit to attending the training in full for each of the three days if they are selected. Space is extremely limited.

Anthony is a nationally recognized impaired driving consultant and CLE provider based in Atlanta, GA. Anthony is a former SFST State Coordinator for the State of Georgia, as well as a former SFST/DRE Staff Instructor for the Georgia Public Safety Training Center.

Because of his expertise in teaching the NHTSA impaired driving training curricula, Anthony was hand-selected by NHTSA as one of only a few SFST Instructors in the country to serve on a national SFST Training Curriculum Assessment Team.

In 2018 and again in 2022, Anthony was the recipient of the "Best of the Best" award from the National Association of Criminal Defense Lawyers, an honor given to the top 20 CLE speakers in the country each year.

Jesse currently lives with his wife and poodle in rural Turner, Maine. He has a solo law office on Lisbon Street in Lewiston.

Jesse is a graduate of the Gerry Spence *Trial Lawyer College* (TLC), which is a 3+ week intensive trial advocacy course. Entrance into the Trial Lawyer's College is based on a competitive application and the training standards are rigorous. In addition, Jesse has successfully completed the Trial Lawyer's College annual week+ long seminar *In Defense of the Damned* which is held for criminal defense attorneys only. Jesse has also graduated from the 2+ week National Criminal Defense College (NCDC).

Jesse has also completed the NHTSA SFST Instructor Development Training Course.

Jesse currently works virtually exclusively on court-appointed criminal defense through PDS. He has worked on 15 homicide cases, 4 of which went to trial, 3 others that went to suppression hearing. He is the Homicide "Resource Counsel" for PDS (feel free to reach out with questions!).
