¹ The Superintendent's Decision and Order does not approve any increase in rates, but instead provides guidance to Anthem in the event the Company chooses to file a revised rate proposal. The percentages in this table that are labeled "Resulting from Decision" indicate the percentage increase that would result from application of the changes to Anthem's rating methodology explained in the Decision and Order that would result in rates the Superintendent could approve.

* The columns marked "Filed" indicate the percentage rate increases that were submitted by Anthem on September 1, 2006. On October 19, 2006, Anthem made revisions to its rate request that included slight reductions in the proposed increases; and on October 23, 2006, Anthem proposed an additional change to its rate request that further slightly reduced the proposed increases.
