

**MAINE REAL ESTATE COMMISSION
CONTINUING EDUCATION COURSE SCHEDULE**

Maine licensees renewing an active real estate license are required to complete a total of 21 clock hours of approved continuing education prior to renewal of the license. The hours must include 3 hours for the core requirement. Please note that the date your license is due for renewal determines which core course you are required to complete. See the Core Course Provider list on the last page of this report for more information in that regard.

The Real Estate Commission has received notification that the following courses will be offered on the dates indicated. All courses on this list are approved by the Commission for the number of hours indicated and may be applied to the renewal or activation requirement for real estate licensees.

CORE COURSE PROVIDERS

CORE COURSE REQUIREMENT

Effective April 1, 2019 the Real Estate Commission core course requirement is dependent upon your license type as follows:

Designated Brokers: *“Core Course for Designated Brokers – 3”*

Brokers and Associate Brokers: *“Core Course for Brokers and Associate Brokers – 3”*

The applicable course is required if:

- your license expiration date is on or after April 1, 2019.
- your license has expired and you renew on or after April 1, 2019.
- you activate a license on or after April 1, 2019.

Licensees with a license expiration date prior to April 1, 2019, who renew prior to April 1, 2019, may fulfill their core course requirement with either *“Core Course for Designated Brokers – 2”* or *“Core Course for Brokers and Associate Brokers – 2”* (depending on your license type) or the core course appropriate for the license type as noted above.
