The hours must include 3 hours for the core requirement. Please note that the date your license is due for renewal determines which core course you are required to complete. CORE COURSE PROVIDERS  
Updated October 21, 2020**

**CORE COURSE REQUIREMENT**

Effective April 1, 2021 the Real Estate Commission core course requirement is dependent upon your license type as follows:

**Designated Brokers:** “Core Course for Designated Brokers – 4- Communication”

**Brokers and Associate Brokers:** “Core Course for Brokers and Associate Brokers – 4 - Communication”

The applicable course noted above is required if:

- your license expiration date is on or after April 1, 2021 (even if you renew before April 1, 2021).
- your license has expired and you renew on or after April 1, 2021.
- you activate a license on or after April 1, 2021.

Licenses with a license expiration date prior to April 1, 2021, who renew prior to April 1, 2021 may fulfill their core course requirement with either “Core Course for Designated Brokers – 3” or “Core Course for Brokers and Associate Brokers –3 ” (depending on your license type) or the new core course appropriate for the license type as noted above.
