XI. BOARD ADMINISTRATOR'S REPORT

Catherine Carroll confirmed the 2021 meeting calendar. Catherine asked if board members had any questions, comments, or concerns regarding the department's legislation and media policy memo, enforcement authority to boards regarding COVID compliance, and an informational document emailed to all licensees being aware of covid safety measures and applicable compliance requirements while practicing. Catherine said it will be very important for the board to assist her when she solicits subject matter expertise from board members on any proposed legislation having a direct or indirect effect on their statute. Catherine anticipates that the staff will present a summary of public comment from the hearing the board held last month on a proposed rule to define electrical installations and to move the Advisory Ruling Chapter at the February 19 meeting. At that time the board should accept or not accept the summarized comments and to provide a response to the public comment. The board ought to vote whether to adopt or not adopt the proposed rule. Catherine informed the board that December 31, 2020 was the cut off date for CPE extensions granted by the board last spring. The board did not wish to extend CPE at this time seeing that there doesn't appear to be a problem for licensees to obtain NEC updates during the pandemic. Catherine and subject matter experts and administrative staff of the trades boards are meeting with PROV for an annual check-in on examination administration and development.

XII. BOARD STATE INSPECTOR'S REPORT

Raymond Stanford requested that the board update information on the website on the anticipated date of adopting the 2020 NEC. The home page was updated to reflect a 'no earlier than May 31, 2021' adoption date.

XIII. OPPORTUNITY FOR PUBLIC COMMENT

Adam Lee of Maine Electrical Institute invited board members for a guided tour (in person or virtual) of the institute's facility. Kevin Dubreuil presented a scenario of a limited electrician employing and supervising the work of a master electrician.
