## V. LD 149 - AN ACT TO FACILITATE LICENSURE FOR CREDENTIALED INDIVIDUALS IN

**OTHER JURISDICTIONS** – PFR Commissioner, Anne Head, presented a newly enacted law that allows the department's regulatory licensing boards and programs to incite individuals from foreign countries with training and education to be licensed in professions and occupations in Maine. In addition to licensing through *credentialling*, the law allows licensing by *endorsement*, which licenses a person with a valid license held in another state whose qualifications are substantially similar to Maine's. Licensing through *credentialing* and *endorsement* is aimed to regulate the competency and to make the licensing processes less complicated especially if the process has already been done in other jurisdictions. Finally, the law allows for *provisional licensing* which aids in employing persons quickly while they obtain a permanent license. Implementing the law will require boards to review its current rules, interpret and understand the requirements

of those educated and trained in other jurisdictions, and adopt rules. The board will continue to exercise its discretion whether to license a person and this new law is not to be perceived as an automatic mandate. This law adds more flexibility and less specificity while keeping the important mission of licensing for public safety.

The board commented on their application of the reciprocity provision in their law; a provision used for years, and the differences between reciprocity, licensing by endorsement, and provisional licensing.
