## V. INTERPRETATION OF §4909 AND LICENSE DESIGNATION

Catherine Carroll reported that C.285 is law as of September 19, 2019 and that the online examination application reflecting the current requirements is in production. To date no applicant has submitted a request to be qualified under the current law. Catherine distributed

Commissioner Head's report presented to IDEAB subcommittee on March 3, 2020 on barriers to credentialing and informed the board that she will be charged with possibly making changes to the statutes and rules in the 130<sup>th</sup> regular session to accommodate foreign examination and licensing applications. There is a "new Mainer" with foreign credentials taking the ASBOG this month. Catherine expressed interest in engaging the board's subject matter experts in consultation with the department's examination vendor in developing and administering the Maine local geologist exam and Maine soil science professional practice exams. Catherine provided basic numbers on the board's budget (expenditures and revenues), licensing pools and examination candidates.
