I. CALL TO ORDER

The meeting was opened by Chair Fontaine at 9:02 a.m.

II. AGENDA MODIFICATIONS

A motion was made by Towle and seconded by Nichols to add dismissal 2021-REC-17797 and consent agreement 2024-REC-19885 to agenda. Unanimous.

III. MINUTES REVIEW AND APPROVAL

A motion was made by Nichols and seconded by Brawn to approve the minutes of the June 20, 2024, meeting. Unanimous.

IV. ADJUDICATORY HEARINGS

2024-REC-19885 Director v. Bernice L. Pipa

The hearing was resolved by a signed consent agreement.

A motion to accept the Consent Agreement was made by Nichols and seconded by Towle. Unanimous.

2024-REC-19739 Director v. Lalah Kargar

Hearing officer – Mark Terison opened the hearing at 9:08 a.m. Lalah Kargar was not present and had no representation. The Director was present. AAG Jim Bowie presented the Director's Case.

Public deliberations were conducted at the close of the hearing.

A motion was made by Brawn and seconded by Fontaine to deny applicant's request to withdraw. Unanimous.

In reference to the grounds for license denial stated in the Notice of Hearing:

- 1. A motion was made by Nichols and seconded by Brawn to affirm the denial of licensure by finding that a preponderance of the evidence demonstrated a violation pursuant to 10 M.R.S. § 8003(5-A)(A)(1). Unanimous.
- 2. A motion was made by Towle and seconded by Nichols to affirm the denial of licensure by finding that a preponderance of the evidence demonstrated a violation pursuant to 32 M.R.S. § 13067-A(1). Unanimous.
- 3. A motion was made by Towle and seconded by Fontaine to affirm the denial of licensure by finding that a preponderance of the evidence demonstrated a violation pursuant to 32 M.R.S. § 13067-A(2). Unanimous.
- 4. A motion was made by Towle and seconded by Brawn to affirm the denial of licensure by finding

- that a preponderance of the evidence demonstrated a violation pursuant to 32 M.R.S. § 13067-A(9) applicant had a professional of occupational license application rejected for reasons related to untrustworthiness within 3 years prior to the date of application. Unanimous.
- 5. A motion was made by Towle and seconded by Fontaine to affirm the denial of licensure by finding that the applicant was foreclosed from challenging the Commission's earlier findings concerning the applicant's inability to demonstrate the required good reputation for honesty, truthfulness, fair dealing and competency under 32 M.R.S. §13191(5) and untrustworthiness under Title 32 M.R.S. § 13967-A(1). Unanimous.

Sanctions

- 1. A motion was made by Brawn and seconded by Towle to order respondent to pay a fine of \$2000.00 to be paid within 90 days of effective date of Decision and Order and prior to submission of a future application. Unanimous.
- 2. A motion was made by Brawn and seconded by Towle to order respondent to pay a fine of \$2000.00 to be paid within 90 days of effective date of Decision and Order and prior to submission of a future application. Unanimous.
- 3. A motion was made by Nichols and seconded by Brawn to order respondent to pay a fine of \$2000.00 to be paid within 90 days of effective date of Decision and Order and prior to submission of a future application. Unanimous.
- 4. A motion was made by Brawn to order respondent to pay a fine of \$1,000 to be paid within 90 days of effective date of Decision and Order and prior to submission of a future application. No second. Motion failed.

A motion was made by Towle and seconded Brawn to order respondent to pay a fine of \$2000.00 to be paid within 90 days of effective date of Decision and Order and prior to submission of a future application. Fontaine, Brawn and Towle voted in the affirmative. Nichols and Peterson opposed. Motion Carried.

A motion was made by Brawn and seconded by Fontaine to issue a REPRIMAND. Unanimous.

Hearing ended at 1:23 p.m. Recording was stopped.
