### ADMINISTRATOR'S REPORT

Board Administrator, Kristina Halvorsen, shared the current licensure numbers with the Board.

Kristina attended a seminar for NASW Maine this week where she shared the Board of Social Worker Licensure's website page updates. Kristina also reiterated the importance of licensees knowing the governing laws and rules for licensure. Kristina also went over the online application process for social worker licenses.

LD1990 (removal of social worker examination requirement) is still waiting on enactors. The Social Worker Compact is still on the appropriation table and is almost complete. Kristina will continue to update the Board with new developments.

Board members asked about future rulemaking. This will be added to future agendas.

### **OPPORTUNITY FOR PUBLIC COMMENT**

Nolan Thompson suggested the Board create and maintain a list of qualifying supervisors who are willing to work with licensees who are mandated by the Board to engage in probationary supervision.
