## V. COMPLAINT PRESENTATION(S) AND BOARD ACTIONS

#### 2024-MFG-20112

A motion was made by Geoffrey Smith and seconded by Patricia Banks to dismiss the complaint in accordance with Chapter 370 Section 5(C) of the Board rules.

#### 2024-MFG-20193

A motion was made by Geoffrey Smith and seconded by Thatcher Butcher to dismiss the complaint in accordance with Chapter 370 Section 5(C) of the Board rules.

Vote: 5 in favor, 2 abstained: Patricia Banks & Theresa Desfosses, 0 opposed.

## 2024-MFG-20395

A motion was made by Geoffrey Smith and seconded by Thatcher Butcher to offer the licensee a consent agreement with terms of probation for a period of 60 days within which the licensee would have to provide proof of installation of the warranty sticker in the home.

Vote: 7 in favor, 0 opposed.

A motion was made by Geoffrey Smith and seconded by Patricia Banks and in the case of failure to provide such proof, the licensee would agree to pay \$500 to be paid within 30 days from the end of the 60 days of probation.

Vote: 7 in favor, 0 opposed.

## **VI. BOARD ACTIONS**

## Review of license application for equivalent experience

A motion was made by Thatcher Butcher and seconded by Geoffrey Smith to table the matter and instructed staff to gather additional information from both the applicant and his supervisor/partners regarding 2 years of work experience; specifically what houses he was involved with (type of home and location), what he actually did in connection with each home, what licensee he worked with, and any further details of what he specifically worked on, such that the board could identify whether his supervised work experience was "equivalent experience" under Chapter 340. A response is due from the applicant within 21 days upon issue of a letter from staff, that outlines the additional information requested. If staff receives enough information to support the application, they can then grant the application. If not, staff can issue a notice of preliminary denial

Vote: 7 in favor, 0 opposed.

Board members discussed establishing specific standards and guidelines to obtain licensure and the need to review other board guidelines as well.

#### **VIII. SENIOR INSPECTOR'S REPORT**

Manufactured housing community routine park inspections have started, and housing complaints are down considering the amount of homes being sold in Maine. More CEO training will be held in the Fall. The rulemaking committee will start up in couple of weeks and plan to meet one morning once every two weeks.

Penny Vaillancourt, Director of OPOR, gave legislative updates. OPOR sat on 3 committees with jurisdiction and addressed legislature, which is challenging due to lots of discontent and misinformation.
