2023-REC-19357 Director v. Jodi L. Beeler

Hearing Officer – Rebekah Smith opened the hearing at 9:05 a.m. Jodi L. Beeler was present and representing herself. The Director was present. AAG John Belisle presented the Director's case.

Public deliberations were conducted at the close of the hearing.

- 1. A motion was made by Nichols and seconded by Towle that a conviction exists pursuant 10 M.R.S. §8003(5-A)(A)(3) and 5 M.R.S. §5301(2)(B) and a preponderance of the evidence did not meet the burden of proof that Beeler was sufficiently rehabilitated. Unanimous.
- 2. A motion was made by Nichols and seconded by Towle that a preponderance of the evidence proved a violation pursuant to 32 M.R.S. §13067-A(2). Towle, Nichols and Fontaine voted affirmative. Peterson opposed. Motion carried.
- 3. A motion was made by Towle and seconded by Nichols that the preponderance of the evidence demonstrated that Beeler did not meet the requirements of 32 M.R.S §13191(5). Unanimous.

A motion was made by Fontaine and seconded by Towle to deny the application. Unanimous.



A motion was made by Nichols and seconded by Peterson to allow Commission Chair Fontaine to sign the Decision and Order when it is written. Unanimous.

Hearing ended at 12:06 p.m. Recording was stopped.
