#### **MINUTES REVIEW AND APPROVAL**

#### **COMPLAINT PRESENTATIONS**

2022-SOC-18392

A motion was made by Linda Butler and seconded by Lee D'Attilio to set the matter for an adjudicatory hearing and offer a consent agreement in lieu of hearing citing Code of Ethics 1.06(B), 1.06(C), and 1.06(H), and imposing a warning, additional supervision of one hour a month for twelve months by an appropriately licensed clinical social worker. Supervision can be through video conference. The supervisor will be required to submit quarterly reports.

Vote: 5 in favor

2022-SOC-18538

A motion was made by Linda Butler and seconded by Lee D'Attilio to set the matter for an adjudicatory hearing and offer a consent agreement in lieu of hearing citing Code of Ethics 1.06(B) and Board Rules Chapter 16(3)(O) and imposing a reprimand, a civil penalty for each of the 4 violations found of \$1,500.00 per violation for a total amount of \$6,000.00.

2022-SOC-18590

A motion was made by Linda Butler and seconded by Christopher Leighton to set the matter for an adjudicatory hearing and offer a consent agreement in lieu of hearing citing Code of Ethics 1.08(A), 1.07(F), and 1.06(D) and imposing a warning, additional supervision of one hour a month for twelve months by an appropriately licensed clinical social worker. Supervision can be through video conference. The supervisor will be

required to submit quarterly reports. Grant the license renewal upon signing the consent agreement. Preliminarily Deny the license if the consent agreement is not signed.

2022-SOC-18596

A motion was made by Lee D'Attilio and seconded by Benjamin Strick to dismiss with a letter of guidance referencing 1.06(D) and 3.04(A) of the Code of Ethics, when seeing multiple people in sessions, to be clear which one is the client. The letter of guidance will stay in the file for 10 years.

Vote: 2 in favor (3 opposed – Karen Lemoine, Christopher Leighton, and Benjamin Strick) Motion did not pass.

A motion was made by Lee D'Attilio and seconded by Benjamin Strick to dismiss with a letter of guidance referencing 1.06(D) and 3.04(A) of the Code of Ethics, when seeing multiple people together to be clear which one is the client. The letter of guidance will stay in the file for 6 years.

A motion was made by Lee D'Attilio and seconded by Karen Lemoine to dismiss with a letter of guidance referencing 3.01(D) of the Code of Ethics and Board Rules Chapter 16(3)(G), ensure that proper recorded supervision is provided to the supervisee. The letter of guidance will stay in the file for 5 years.
