**CALL TO ORDER**

The meeting was called to order by the Chair, John Ackley at 9:01 a.m.

**MINUTES REVIEW AND APPROVAL**

A motion was made by Burnett and seconded by Kanoti to approve the September 28, 2023, minutes. Unanimous.

**ELECTION OF OFFICERS**

A motion was made by Burnett and seconded by Kanoti to elect Ackley as Chair, Kanoti as Vice-Chair and Shina as Complaint officer. Unanimous.

**LETTER OF GUIDANCE**

**FORESTRY SERVICE SETTLEMENT AGREEMENT REQUEST**

AAG Stivers brought her findings to the board. The Forest Service will not include a provision in their settlement agreements to require licensed foresters to self-report to the Board and recommended that the administrator subscribe to email notifications for settlement information. Administration has subscribed and will monitor. No further action from the board.

### Applications for Board Review

First application: A motion was made by Burnett and seconded by Ackley to approve education listed on application to qualify licensee for intern forester licensure. Ackley, Shina, and Burnett voted in the affirmative. Kanoti opposed. Motion Carried.

### License Activation Request

A motion was made by Burnett and seconded by Ackley to accept the waiver with the requirement that the licensee submit evidence of completion of six (6) hours of continuing education required for 2022 license renewal, to be provided within 60 days. Unanimous.
