Board Chair, Linda Butler, called the meeting to order at 9:08 a.m.

A motion was made by Angela Fileccia and seconded by Christopher Leighton that the first allegation (10 M.R.S. § 8003(5-A)(A)(1) for the practice of misrepresentation, fraud or deceit in connection with services rendered as a social worker, as defined in Board Rules, Chapter 16 § 1(1)(B)(2) by intentionally misrepresenting the type or status of

license held or qualifications to practice) was proven by the preponderance of the evidence.

A motion was made by Angela Fileccia and seconded by Lee-Andra D'Attilio that the second allegation (10 M.R.S. § 8003(5-A)(A)(2) for violation of an applicable code of ethics as adopted in Board Rules, Chapter 16 § 1(4), specifically the National Association of Social Workers (NASW) Code of Ethics § 4.04: social workers should not participate in, condone, or be associated with dishonesty, fraud, or deception) was proven by the preponderance of the evidence.

Vote: 4 in favor, 1 recused: Benjamin Strick.

A motion was made by Angela Fileccia and seconded by Lee-Andra D'Attilio that the third allegation (10 M.R.S. § (5-A)(A)(2) for violation of an applicable code of ethics as adopted in Board Rules, Chapter 16 § 1(4), specifically the NASW Code of Ethics § 4.06(c): social workers should ensure that their representations to clients, agencies, and the public of professional qualifications, credentials, education, competence, affiliations, services provided, or results to be achieved are accurate. Social workers should claim only those relevant professional credentials they actually possess and take steps to correct any inaccuracies or misrepresentations of their credentials by others) was proven by the preponderance of the evidence.

Vote: 4 in favor, 1 recused: Benjamin Strick.

A motion was made by Linda Butler and seconded by Lee-Andra D'Attilio to issue a reprimand, a civil penalty of \$750 per violation (\$2250 total) to be paid within 6 months, and a revocation of license.

ADMINISTRATOR'S REPORT

Board Administrator, Kristina Halvorsen, discussed current legislative bills that may affect this Board. LD 227, a bill to ensure access to care and to protect reproductive and gender affirming care in Maine, is a shield law that may conflict with the Social Work Compact regarding disciplinary data sharing and complaint investigations.

LD 1990, a bill to remove the examination requirement for social worker licensure, was passed as a legislative study. This study will review all of Maine's social worker licensure requirements. Kristina expects to be part of this study panel.

LD2140, the Social Work Compact, was passed. Either a Board Administrator or a Board member needs to be part of the compact commission. Kristina will forward Board members information regarding the development of this commission. If any Board members wish to be involved in this commission, they should contact Kristina.

Kristina discussed recent Board staff recruitment activities and hires.

Board staff, Michael Tarr, shared the recent updates made to the Board's OPOR website.
