## V. INTERPRETATION OF CHAPTER 73, SECTION 4906

The Board reviewed correspondence from Austin Young dated September 3, 2024, which asked whether he would qualify for the exemption to licensure in 32 M.R.S. § 4906(1). Section 4906(1) provides: "A person not a resident of and having no established place of business in this State, practicing or offering to practice in the profession of geologist or soil scientist when that practice does not exceed in the aggregate more than 30 days in any calendar year, as long as that person is licensed to practice the profession in the person's own state or country in which the requirements and qualifications for obtaining a license are equivalent to those specified in this chapter." Mr. Young, who is not licensed by the Board, represented in his correspondence that he is a resident of Maryland, holds a Certified Professional Soil Scientist certification from the Soil Science Society of America, and has been asked to provide a soil survey in the Town of Lisbon that would be completed over a period of less than 30 days. The Board discussed the fact that Maryland does not issue soil scientist licenses, and it was unclear whether Maryland requires certification by the Soil Science Society of America to practice soil science in that state. The Board therefore could not determine whether the requirements and qualifications in Maryland are equivalent to Maine's.
