#### **PUBLIC COMMENT**

One public comment was received for clarification on the order of complaint cases discussed, which was clarified. No other comment received.

After public comments, Davis raised a concern with the lack of board member appointments. Hoenig referred to a person of interest but is unclear if they have applied to the Governor's Office. Davis is concerned with the complaint officer's role and time spend on both reviewing complaints and the role of compliant treatment records reviewer. Davis questioned the need for two separate board members to do the work. Oneto act as the complaint officer and another to act as the compliance officer to review treatment records.
