The presentation included model documents, member communications, centralized licensing database (VIVA) – database exchange program. VAULT - license verifications obtained through an online portal. License transfers, database to database exam scores. Racetrack – to find and track CE for auditing purposes. Other licensing assistance programs discussed, VTNE, SPA, PAVE.
