McCormack made a motion to offer a consent agreement to resolve cases 2025-PHA-20930, 2025-PHA-20886 and 2025-PHA-2088 to include the following: 1. Reprimand 2. 60-day suspension of pharmacist license 3. Suspension on Pharmacist in Charge License for 6 months 4. Probation for 3 years requiring self-reporting of all dispensing errors including prescriptions dispensed to wrong patient, wrong drug, wrong directions, wrong dose or wrong quantity, and if not accepted schedule for an adjudicatory hearing, seconded by Emmons. Haar and Kane in favor; Complaint Officer Norberg abstained; Ahmed and Hamilton absent.

Board confirmed receipt of materials sent by National Association of Boards of Pharmacy (NABP), there was no discussion.

DIRECTOR REPORT

OPOR Director Penny Vaillancourt discussed with board the DEA rule requirement for mail order pharmacies, and a DEA attestation form created for companies without a DEA number, a copy was provided to the board for review.

OPOR Director Penny Vaillancourt briefly spoke to Board members about upcoming rulemaking with the board of complementary medicine, Board member Haar said they would be willing to be the pharmacist on the subcommittee working on the formulary list.

Michelle Aytay from Walgreens thanked the board for their hard work and wanted to make sure the central fill rules were moving forward.
