MINUTES OF August 1, 2025  
BOARD MEETING

**CALL TO ORDER:** The meeting was called to order by Dr. Smith, O.D. at 9:03 a.m. Members present, Eric Hebert, O.D, James Smith, O.D., James Murphy, Public Member, Timothy Rioux, O.D., (zoom) and Todd Hamilton, O.D. (zoom)

Others present: Tina Carpentier, Office Specialist II, Lisa Wilson, Assistant Attorney, four citizens present, and four citizens were listening on Zoom.

**OLD BUSINESS:**

Action on May 1, 2025, Meeting: A motion was made by Dr. Hebert, second by James Murphy to accept the minutes as written.

The motion passes 5 in favor and 0 opposed.

Email March 4 and 6, 2025 Dr. Salvat: Tabled from the Board meeting in May. The Board asked for clarification on what Dr. Salvat is asking for. Wavier or more time to complete continuing education credits. Dr. Salvat wanted more time to complete his continuing education and has completed all required CE 25 hours within the deadline of March 31, 2025.

Letter from Dr. Sheridan Gove, O.D. received on July 22, 2025, requesting the Board to revisit and reverse their decision on the consent agreement she signed on October 28, 2020.

A motion was made by James Murphy, seconded by Dr. Hebert to elect Dr. Rioux as Continuing Education Officer.

Budget: Tina Carpentier provided budget information regarding the costs of remaining an independent Affiliated Board. The Board will review budget implications and potential fee increases after receiving more information from the August 2025 meeting with The Office of Professional and Occupational Regulations (OPOR).

No action taken by the Board.

Affiliated Board vs. OPOR: The Board discussed transitioning from an affiliated to OPOR. The Board expressed concerns about losing autonomy, potential impact on rulemaking and future governance. The Board will meet with Commissioner Cohen and Director Penny Vaillancourt in August to gather more information about the transition implications. The Board will revisit with a decision expected after receiving the additional information.

No Action Taken by the Board.

Dr. Rioux review of the ARBO Annual meeting: Dr. Rioux shared insights on available resources, including the ARBO website and new exam options. He also briefly touched on upcoming telehealth and AI issues, noting concerns about AI potentially being used to circumvent the doctor-patient relationship. The Board will send a member to the Annual ARBO meeting in June of 2026.

Stakeholder From the Board of Optometry for LD1803 Study Group: The Board needs to elect a Stakeholder for the LD1803 study group, meeting date will be one day in September, October and November between the hours of 7:00am and 9:00am.

A motion was made by Dr. Rioux, seconded by Dr. Hebert to elect Dr. Smith as Stakeholder for the LD 1803 Study Group.

The motion passes 4 in favor and Dr. Smith abstained.

**2025-OPT-20745:** After presentation and discussion, a motion was made by Dr. Hamilton, seconded by Dr. Rioux to dismiss the complaint on the grounds of no violation of the Maine Optometry Laws and Rules; however, an assessment of a late fee to the licensee as specified in the board statute.

The motion passes 4 in favor and 1 abstained (Dr. Smith)

**2025-OPT-20781:** After presentation and discussion, a motion was made by James Murphy, seconded by Dr. Hebert, to dismiss the complaint on the grounds of no violation of the Maine Optometry Laws and Rules.

The motion passes 4 in favor and 1 abstained (Dr. Smith)
