#### **Chapter 5-A: LICENSURE BY ENDORSEMENT**

<u>Summary:</u> This Chapter outlines the process to issue a license by endorsement to an applicant who presents proof of licensure by another jurisdiction of the United States as long as the other jurisdiction maintains substantially equivalent license requirements.

#### 1. LICENSURE BY ENDORSEMENT

An individual applying for a license by endorsement must meet the following requirements:

#### 1. License from Another U.S. Jurisdiction

An applicant licensed under another jurisdiction who seeks licensure in Maine pursuant to 10 M.R.S. § 8003-H must:

- A. Hold a valid, active alcohol and drug counselor license issued by another jurisdiction of the United States that maintains substantially equivalent license requirements for the type of license sought;
- B. Submit a completed application form; and
- C. Submit any fee as required by Chapter 10 of the rules of the Office of Professional and Occupational Regulation.

#### 2. Substantially Equivalent License Requirements

"Substantially equivalent license requirements" means that the jurisdiction maintains a pathway for initial licensure that at a minimum requires the education, experience and examination as set forth in Sections 2(A) and 2(B).

#### A. Certified Alcohol and Drug Counselor (CADC)

- i. Documented proof of an associate degree or higher from an accredited institution of higher education in clinically based behavioral sciences, addiction counseling, or in a related field as described in Board Rules Chapter 4, Section 2(1); and
  - ii. Proof of a passing score on an examination.
  - B. Licensed Alcohol and Drug Counselor (LADC)
    - i. Documented proof of an associate degree, bachelor's degree or higher from an accredited institution of higher education in clinically based

	behavioral sciences or addiction counseling, or in a related field as
	described in Board Rules Chapter 5, Section 2;
ii.	Completion of supervised work experience while being supervised by a
	licensed clinical supervisor, consisting of counseling services of
	individuals, families, or groups, as part of the treatment and
	rehabilitation of persons using alcohol or other drugs; and

iii.	Proof of a passing score on an examination.
