There are committees on rules, compliance, finance, elections and communications. Board member Fileccia volunteered to sit on the rules committee. NASW, CSWE and ASWB will also have representatives on the committees. These smaller committees will meet much more frequently than the full commission. The full commission will meet annually after the initial details are determined.

The interstate compact was reviewed in depth. There were also discussions about the software database and licensing fees to join the compact. All northeast states near Maine have joined the Social Work Compact except for Massachusetts.

Kristina will forward Board member Fileccia's notes from the Social Work Compact meeting to all Board members.
