Implementation of LD 149 (c. 167)

Foreign Trained applicants and license by endorsement.

Commissioner Anne Head addressed the Board regarding the implementation of LD 149 which went into effect October 18, 2021 that focuses on changes to address the need to reduce licensing barriers. Commissioner Head hopes by the implementation it will help foreign training individuals and applicants who hold a valid license in another State who want to live and work in Maine. LD 149 would allow applicants to receive a provisional license until all the licensing requirements are met. Commissioner Head asked the Board to review their licensing standards and rules to make sure there are not any requirements that are not necessary. Commissioner Head thanked the Board for their service to the people of Maine.

Sarton moved to preliminarily deny licensure to Samantha Maldonado as the educational requirements were not met pursuant to 32 M.R.S. §12512 Section 1(B)(1) and inform the applicant if she was to obtain licensure in another State she may apply for licensure by endorsement if the requirements are substantially equivalent, seconded by Tewhey. Unanimously voted.

CORRESPONDENCE

Tiffany Wagner, prescribing authority of Naturopathic Doctors

The Board discussed the correspondence and believes that naltrexone is botanically derived and meets the criteria of other drugs that are a botanical extract or its derivatives and is acceptable to prescribe within the prescriptive authority of a naturopathic doctor.

REQUEST FOR AN ADVISORY RULING

Nicole Egenberger regarding requirement of collaborative relationship

The Board requested that staff respond to inform Nicole Edgenberger Pursuant to 32 M.R.S. § 12522, Section 4, prior to independently prescribing noncontrolled legend drugs, a naturopathic doctor shall establish and complete a 12-month collaborative relationship with a licensed allopathic or osteopathic physician to review the naturopathic doctor's prescribing practices.
