Norberg moved to issue an extension to the Board Statement issued May 19, 2022 regarding beyond-use dating of intravenous iodinated contrast media drugs during active shortage. In order to protect the public health and welfare, the Board issues the following extension for the period of 30 days, the Board will not consider it "unprofessional conduct" for purposes of Board Rules Chapter 29, when a licensed pharmacist assigns a beyond-use date to a repackaged intravenous iodinated contrast media drug, provided that the beyond-use date complies with the guidance contained in the USP's "Operational Considerations for Sterile Compounding During Covid-19 Pandemic." seconded by White. Unanimously voted.

BOARD ACTION ON WAIVER REQUEST
