This temporary license allows the person to practice occupational therapy under the supervision of a licensed occupational therapist. If you have passed the certification exam, you are not eligible for temporary licensure.

- Verification of licensure for each license you hold or have held (see verification of license instructions on page 7).

#### Requirements for change of status, Occupational Therapy Assistant

- Completed application for permanent licensure;
- Payment of \$30.00 license fee;
- Official Transcript, if not previously submitted;
- Official score report from NBCOT (only for applicants applying within 3 months of having passed the exam) **or** official verification of certification form from NBCOT;
- Completed verification of supervision form (see page 6); and
- Verification of licensure for each license you hold or have held (see verification of license instructions on page 7).

- Payment of \$35.00 occupational therapist license fee; or
- Official Transcript, if not previously submitted;
- Official score report from NBCOT (only for applicants applying within 3 months of having passed the exam) **or** official verification of certification form from NBCOT; and
