# RULEMAKING – REVIEW AND ACCEPT THE BASIS STATEMENT AND RESPONSE TO COMMENTS AND VOTE TO ADOPT RULES

- 1. Chapter 4-A, Administration of Drugs and Vaccines (Amend)
  McCormack moved to adopt the rule, seconded by Hamilton. Unanimously voted.
- 2. Chapter 41, Sale of Nonprescription Drugs Through Vending Machine Outlets (New) McCormack moved to adopt the rule, seconded by Hamilton. Unanimously voted.
- 3. Chapter 42, Compounding Drugs for Veterinary Office Use (New)

  McCormack moved to accept the comment regarding Section 3(2)(B) and amend the rule to eliminate the requirement for the pharmacy to collect a signed acknowledgement from a veterinarian; seconded by Norberg. Unanimously voted.

McCormack moved to accept the comment regarding Section 3(2)(B)(iii) and Section 4(8) and amend the rule to increase the dispensing limit from the proposed 120-hours (5-days) to 14 days (336-hours), seconded by Ahmed. Unanimously voted.

McCormack moved to accept the comment regarding Section 4(8) and amend the rule to read "Compounded Preparation for Vet Office Use Only. Intended only for dispensing and admin for nonfood-producing animals as determined by the prescribing vet", seconded by Norberg. Unanimously voted.

Hamilton moved to amend the motion to eliminate *Preparation* and fully say "administration", seconded by McCormack. Unanimously voted.

McCormack moved to not accept the comment regarding 503B outsourcing facilities as the Board does not have licensing authority, seconded by Hamilton. Unanimously voted.

McCormack moved to not accept the comment for assurance that the veterinarian is not held responsible or disciplined should an owner eat a pet pig or chicken after the pet consumes the compounded prescription drug because the Board of Pharmacy does not license, regulate, or impose discipline related to the practice of veterinary medicine on dispensing a prescription drug and associated practice, seconded by Haar. Unanimously voted.
