Agreement in include the following: 1) Admission to violation of 10 M.R.S. § 8003(5-A)(A)(5) for violating a Board Rule Chapter 30 § 16 and 32 M.R.S. §13742-A(C); 2) Warning; 3) \$1,500.00 Fine; 4) Additional conditions of existing probation period until December 5, 2029, conditions of probation include a) The licensee may not serve as a pharmacist in charge at more than one location beginning ninety (90) days from the final signature on the consent agreement; b) Completion of ten (10) hours of board-approved continuing education and at the licensees sole expense on proper controls and policies on the handling of controlled substances and prescription drugs, and the legal duties and responsibilities of a pharmacist to maintain the pharmacy fill area to be completed within ninety (90) days, the licensee is to submit the proposed continuing education courses to the Board's Complaint Officer for prior approval; following completion, the licensee shall submit proof of completion immediately upon completion of the courses. The continuing education credits may not be used to fulfill the continuing education required for relicensure; 3) Within ninety (90) days of completion of the 10 hours of continuing education imposed, the Licensee shall also submit to the Board for review the policies and procedures for operation of the retail pharmacy located in Eastport, with any updates he has made as a result of his coursework, seconded by McCormack, Kane, White, Norberg, Haar, McCormack and Ahmed in favor, Complaint Officer Hamilton abstained.
