**Maine Children's Trust Incorporated - Maine**

**Children's Trust** was established to work toward the prevention of child abuse and neglect in Maine. All funds contributed are used to support this cause through advocacy, education, and the funding of community-based activities and programs throughout Maine. The fund is administered by the Maine Children's Trust Incorporated.



**Human Leukocyte Antigen Screening Fund** - Donations to the fund will be used to support bone marrow screening. The fund is administered by the Department of Human Services.

**B. PARK PASSES**



Maine Park passes can be purchased through Maine Revenue Services when you file your income tax return. You may purchase a total of up to three passes to Maine state parks for yourself and other individuals. Park passes can be purchased at a cost of \$20 for an individual season pass and \$40 for a vehicle season pass. An individual pass allows only the pass holder admittance to day use of Maine state parks and historic sites. A vehicle pass allows all occupants of the vehicle admittance to day use. **These passes do not include entry into Baxter State Park, Allagash Wilderness Waterway, the Penobscot River Corridor or Scarborough Beach.** Any pass purchased will reduce the amount of your refund or increase the amount you owe.

**Lines 9-11.** Enter your personal information (or the information belonging to the person for whom you wish to purchase a pass) in the space provided. YOU MUST FILL IN THE NAME AND ADDRESS INFORMATION COMPLETELY. Check the box that corresponds to the type of pass you wish to purchase (Individual or Vehicle) and write the correct amount in the boxes to the right. **Note: You may purchase park passes through Maine Revenue Services with excess refund amounts, checks or money orders. You may also purchase a park pass directly from the Bureau of Parks and Lands.**

**Line 12.** Add all of the amounts entered on lines 9-11 and enter the total on this line.
