To: Unorganized Territory Property Owners

RE: Valuation Adjustment

Maine law and the Maine Constitution require that assessors periodically update property values to maintain equity in the assessment of property taxes and meet certain minimum standards. To comply with these requirements, the Property Tax Division of Maine Revenue Services has recently conducted an in-depth review of real estate sales throughout the unorganized territory. As a result of this review, we have updated our land and building pricing schedules for the coming tax year. These changes may result in an adjustment to the assessed value of your property.

You will receive your unorganized territory inventory form with your 2025 assessed value within the next 2 weeks. This represents our estimate of the 100% market value of your property as of April 1, 2025.

Your inventory form will have a Letter ID, this letter ID allows you to complete your inventory form on The Maine Tax Portal. You should expect to receive your 2025 tax bill in the first week of August.

Representatives from the Property Tax Division will be available to meet with you individually to answer questions and discuss any concerns you may have regarding your assessed value. To ensure everyone has equal opportunity to meet with Division staff, meetings will be held by appointment only. We will have your property record card available at the meeting to review with you.

If you are unable to make an appointment or would prefer not to meet in person, you can contact our office 9:00 – 4:00 Monday thru Thursday and 9:00 – 12:00 Friday, excluding holidays, to review your assessment with the staff.
