This credit is limited to your Maine income tax liability. If you did not use all of the credit on line 2 this year, you may carry the unused portion forward for up to 15 years.

2014 MAINE FISHERY INFRASTRUCTURE INVESTMENT TAX CREDIT WORKSHEET INSTRUCTIONS

An income tax credit is available for investments in, or contributions to, public fishery infrastructure projects. The credit is equal to 50% of the eligible investment or contribution, as certified by the Department of Inland Fisheries and Wildlife, and must be taken in equal installments over four years. The investment/contribution limit per project is \$5,000,000. The credit taken in any year is limited to 50% of the tax liability for that taxable year. Any portion of the credit left unused due to this limitation may be carried forward for up to 15 years. The credit is subject to recapture and is prohibited if the taxpayer claims a federal income tax deduction for the investment or contribution.

In the case of pass-through entities (such as partnerships, LLCs, S corporations, and trusts), the partners, members, shareholders, beneficiaries or other owners are allowed a credit in proportion to their respective interests in these entities. If you are a member of a pass-through entity, enter on lines 1a, 1b and 1c your share of the tax credit certificates reported to you by the entity.
