- The purchase of a Maine park pass(es) provides authorization for MRS to share your name and mailing address with the Bureau of Parks and Lands.
- MRS will issue park passes through July 31, 2025. For additional park pass options, fees, and rules, or to purchase your park pass **online** directly from the Bureau of Parks and Lands, visit: [MaineStateParkPass.com](http://MaineStateParkPass.com).
- If you are filing an amended return, the correct amount of your charitable contributions and park passes **must** agree with the total amounts shown on your original return. Contribution and park pass amounts cannot be changed on your amended return.

Any voluntary charitable contribution you make on lines 1 through 8 above may qualify for a charitable contributions deduction on your 2025 federal and Maine income tax returns if you itemize deductions.
