Specific Instructions for the Cannabis Excise Tax Return

Please note: This return must be filed even if there are no taxable sales to report.

Line 1 – Cannabis Flower (wet). Enter on line 1a the total amount of pounds of wet cannabis flower that has been sold or transferred to other licensees. Multiply this amount by 0.25 and enter the result on line 1b. Multiply the amount on line a by \$335.00 and enter the result on line 1c.

Line 2 – Cannabis Flower (other). Enter on line 2a the total amount of pounds of cannabis flower that have been dried, cured or otherwise prepared and sold or transferred to other licensees. Multiply this amount by 1.00 and enter the result on line 2b. Multiply the amount on line 2b by \$335.00 and enter the result on line 2c.

Line 3 – Mature Cannabis Plant (wet). Enter on line 3a the total number of wet mature cannabis plants that have been sold or transferred to other licensees or that were purchased or transferred from a registered caregiver or registered dispensary. Multiply this amount by 1.00 and enter the result on line 3b. Multiply the amount on line 3b by \$35.00 and enter the result on line 3c.

Line 4 – Mature Cannabis Plant (other). Enter on line 4a the total number of mature cannabis plants that have been dried, cured or otherwise prepared and sold or transferred to other licensees, or that were purchased or transferred from a registered caregiver or registered dispensary. Multiply this amount by 1.00 and enter the result on line 4b. Multiply the amount on line 4b by \$35.00 and enter the result on line 4c.

Line 5 – Cannabis Trim (wet). Enter on line 5a the total amount of pounds of wet cannabis trim (not including the central stalk or roots of the plant) that have been sold or transferred to other licensees. Multiply this amount by 0.25 and enter the result on line 5b. Multiply the amount on line 5b by \$94.00 and enter the result on line 5c.

Line 6 – Cannabis Trim (other). Enter on line 6a the total amount of pounds of cannabis trim (not including the central stalk or roots of the plant) that have been dried, cured or otherwise prepared and sold or transferred to other licensees. Multiply this amount by 1.00 and enter the result on line 6b. Multiply the amount on line 6b by \$94.00 and enter the result on line 6c.

Line 7– Immature Plants/Seedlings. Enter on line 7a the total number of immature cannabis plants and seedlings that have been sold or transferred to other licensees or that were purchased or transferred from a registered caregiver or registered dispensary. Multiply this amount by 1.00 and enter the result on line 7b. Multiply the amount on line 7b by \$1.50 and enter the result on line 7c.

Line 8 – Cannabis Seeds. Enter on line 8a the total number of cannabis seeds that have been sold or transferred to other licensees or that were purchased or transferred from a registered caregiver or registered dispensary. Multiply this amount by 1.00 and enter the result on line 8b. Multiply the amount on line 8b by \$.30 and enter the result on line 8c.

Line 9– Total Due. Total lines 1c through 8c.

Line 10 – Credit Carry Forward from Prior Period. If your prior return resulted in a credit balance and you have received a notice from Maine Revenue Services confirming this credit, enter the amount of your credit here.

Line 11 – Amount Due. Subtract line 10 from line 9 (If the result is a credit amount, use line 12.)

Line 12 – Credit Due. If the result of subtracting line 10 from line 9 is a credit, enter that amount here. This credit will automatically forwarded to the next open period. If you wish this credit to be refunded to you, you must check the box.
