Sales Tax Bulletin Updates

The Sales Tax Division has posted two bulletin updates to the MRS website:

- Bulletin No. 12 Retailers of Food Products. The bulletin was updated to remove "menstrual products" from a chart of examples of taxable non-food products that may be sold by a retailer of food products. Menstrual products will be exempt from sales tax beginning on October 1, 2021.
- Bulletin No. 41 Medicines, Medical Equipment and Prosthetic Devices. The bulletin was updated to reflect that sales of all equipment and supplies used in the diagnosis or treatment of human diabetes are exempt from sales tax when used by the purchaser. Other nonsubstantive changes were also made.
