MRS Rulemaking Activity Proposed Rule

Rule 202, "Tree Growth Tax Law Valuations." MRS is proposing to repeal and replace Rule 202 to provide updated valuation rates for each forest type, by economic regain, for parcels classified under the Tree Growth Tax Law. 36 M.R.S. § 576 requires that the State Tax Assessor annually establish the value per acre for forest type, by economic region, for parcels classified under the Tree Growth Tax Law. Comments on the proposed changes for Rule 202 are due by March 14, 2025.

Adopted Rule

Rule 308, "Direct Payment Permits." Effective February 15, 2025, MRS has adopted amended Rule 308 to conform the Rule with statutory changes in P.L. 2023, c. 643, Pt. H and P.L. 2023, c. 673 (generally imposing sales tax on leases and rentals), and to make other minor technical language changes. Rule 308 establishes a system for combined reporting of purchases by manufacturers and utilities under a direct payment permit for sales tax purposes.
