## MRS Rulemaking Activity Adopted Rules

Rule 102, "Electronic Funds Transfer (EFT)." Effective May 3, 2023, MRS has adopted amended Rule 102 to reflect the current EFT methods available for payment of Maine taxes and to make other technical updates. Specifically, the rule removes references to the ACH Teledebit payment method, which has been discontinued, and adds references to the Maine Tax Portal ("MTP").

Rule 202, "Tree Growth Tax Law Valuations - 2023." Effective May 3, 2023, MRS has repealed and replaced Rule 202 to provide updated valuation rates for each forest type, by economic region, for parcels classified under the Tree Growth Tax Law. Rule 202 is updated annually by MRS.

**Rule 805, "Composite Filing."** Effective May 3, 2023, MRS has adopted amended Rule 805 to reflect how a federal partnership audit administrative adjustment request ("AAR") or final federal adjustment ("FFA") affects the filing of a composite return, and to make other technical updates.

**Rule 808, "Corporate Income Tax Nexus."** Effective May 3, 2023, MRS has adopted amended Rule 808 to reflect recently enacted legislation that provides for an exemption to the standard nexus rules for certain out-of-state suppliers of spirits to the Bureau of Alcoholic Beverages and Lottery Operations ("BABLO"), and to make other technical updates.

Rule 810, "Maine Unitary Business Taxable Income, Combined Reports, and Tax Returns." Effective May 3, 2023, MRS has adopted amended Rule 810 to reflect recently enacted legislation that provides for an exemption to the standard nexus rules for certain out-of-state suppliers of spirits to the Bureau of Alcoholic Beverages and Lottery Operations ("BABLO"), and to make other technical updates.

Rule 812, "Credit for Educational Opportunity." Effective May 3, 2023, MRS has adopted amended Rule 812 to reflect recently enacted legislation that limits the program to tax years beginning before January 1, 2022, and to make other technical updates.

Rule 813, "Property Tax Fairness Credit." Effective May 3, 2023, MRS has adopted amended Rule 813 to reflect recently enacted legislation that provides for an additional income tax credit for veterans totally and permanently disabled, and to make other technical updates.

# The Maine Tax Portal is Here! Maine I-File, EZ-Pay, and MEETRS for Business Taxes Deactivated Soon

The Maine Tax Portal, Maine Revenue Services' new online system, is now open for you and many of your business clients to file, pay, and manage state taxes. The Maine Tax Portal is replacing I-File, EZ-Pay, and MEETRS for certain business taxes, which will be deactivated on May 31, 2023. After May 31, the Maine Tax Portal will be the only way to electronically file Maine business taxes online.

It is imperative that you and your eligible clients go to <u>revenue.maine.gov</u>, create a username, and begin using the Maine Tax Portal to file, manage and pay your Maine business taxes. A list of the business taxes and programs that are eligible for use on the Maine Tax Portal are listed at <u>maine.gov/revenue/portal</u>.
