2023 State of Maine Individual Income Tax Rates

As is required by State statute, Maine individual income tax rate schedules have been updated for inflation for 2023. Tax rate schedules for tax years beginning in 2023 are available at: <a href="https://www.maine.gov/revenue/sites/maine.gov/reve

For tax years beginning in 2023, an inflation adjustment is made by multiplying the cost-of-living adjustment, 1.166, by the lowest dollar amounts of the tax rate tables specified in 36 M.R.S. §§ 5111(1-F), 5111(2-F), and 5111(3-F) and by multiplying the cost-of-living adjustment, 1.162, by the highest dollar amounts of the tax rate tables specified in 36 M.R.S. §§ 5111(1-F), 5111(2-F) and 5111(3-F). The Maine personal exemption amount is adjusted by multiplying the cost-of-living adjustment, 1.144, by the dollar amount of the personal exemption specified in 36 M.R.S. § 5126-A(1), for the taxpayer and taxpayer's spouse, if married. *See* 36 M.R.S. § 5403. The Maine standard deduction amount is equal to the federal standard deduction amount.

MRS Tax Compliance and Tax Collection Telephone Assistance Outage Thursday, November 10, 2022, at Noon

MRS Sales Tax Bulletin Update

The Sales, Fuel & Special Tax Division has posted **General Information Bulletin No. 112** to the MRS website. The Bulletin contains details about legislation enacted during the Second Regular Session of the 130th Legislature that affect taxes administered by the Division, including important information on the newly-enacted definitions, exemptions, and amendments to sales tax laws for the Penobscot Nation, the Passamaquoddy Tribe, the Houlton Band of Maliseet Indians, and the respective tribal members and tribal entities as found in P.L. 2021, c. 681.
