2023 Maine Individual Income Tax Withholding Tables

The 2023 Maine Withholding Tables for Individual Income Tax have been published and are available at: www.maine.gov/revenue/tax-return-forms/employment-tax-returns-2023.

Sales Tax Bulletin Updates

The Sales Tax Division has posted two bulletin updates to the MRS website:

- Bulletin No. 13 Sales of Fuel and Utilities. This bulletin was updated to include information on the exemption from sales tax on residential electricity consumed by eligible customers enrolled in a low-income assistance program administered by the Maine State Housing Authority under 35-A M.R.S. § 3214(2), or in an arrearage management program administered by electric transmission and distribution utilities under 35-A M.R.S. § 3214(2-A).
- Bulletin No. 20 Lease and Rental Transactions. This bulletin was updated to remove the modifier "pickup" from references to trucks and vans rented by persons primarily engaged in the business of renting automobiles.

MRS Conforms to Certain Federal Tax Relief in Disaster Situations

MRS has announced Maine tax filing relief for those located in federally declared disaster areas. Taxpayers who reside or have a business located in a federally declared disaster area as noted below will have additional time to file tax returns and submit tax payments.

The relief applies to all Maine taxes administered by MRS, including Sales and Use Tax, Motor Fuel Taxes, Individual and Corporate Income Taxes, the Estate Tax, and Financial Institution Franchise Tax. Note that the relief includes extended return filing due dates but does not include tax payments originally due before the disaster date.

• <u>Hurricane Ian</u> – Returns and tax payments due on or after: September 23, 2022, for those in Florida; September 25, 2022, for those in South Carolina; or September 28, 2022, for those in North Carolina; must be filed and paid on or before February 15, 2023.

MRS will abate any penalties or interest that would otherwise apply.

To qualify for relief, affected taxpayers should write "HURRICANE IAN" across the top of their return. Businesses or individuals located in the federally declared disaster area who are assessed penalties or interest for filing returns or paying taxes late during the relief period should contact MRS at (207) 626-8475 (Income Tax programs), (207) 624-9693 (Sales Tax programs), or (207) 624-9609 (Motor Fuel Tax programs) to request abatement of any penalties or interest.

If the IRS grants relief to other areas affected by the hurricane or grants an additional relief period, MRS intends to grant similar relief to affected Maine taxpayers.
