Updated 2024 State of Maine Individual Income Tax Rates

As is required by State statute, Maine Individual Income Tax rates have been updated for inflation for 2024. Tax-rate schedules for tax years beginning in 2024 are available at: www.maine.gov/revenue/sites/maine.gov/revenue/sites/maine.gov/revenue/files/inline-files/ind tax rate sched 2024.pdf.

For tax years beginning in 2024, an inflation adjustment is made by multiplying the cost-of-living adjustment, 1.238, by the lowest dollar amounts of the tax-rate tables specified in 36 M.R.S. §§ 5111(1-F), 5111(2-F), and 5111(3-F) and by multiplying the cost-of-living adjustment, 1.233, by the highest dollar amounts of the same tax-rate tables. The Maine personal exemption amount is adjusted by multiplying the cost-of-living adjustment, 1.215, by the dollar amount of the personal exemption specified in 36 M.R.S. § 5126-A(1), for a taxpayer and taxpayer's spouse, if married. See 36 M.R.S. § 5403. The Maine standard deduction amount is equal to the federal standard deduction amount.

Reminder of Compliance with Maine Property Tax Laws

It has come to our attention that certain municipalities in Maine may not be in compliance with the requirement to properly assess personal property within their municipalities. The Maine Constitution and Title 36 of the Maine Revised Statutes require that taxes on real and personal property be apportioned and assessed equally according to the just value thereof.

In accordance with the annual state valuation process, Maine Revenue Services ("MRS") must certify to the Secretary of State the full equalized value of all real and personal property that is subject to taxation under the laws of Maine. Failure to comply with the requirement to assess personal property could directly impact the accuracy of state valuation and MRS's certification thereof to the Secretary of State.

Please review your municipality's assessment practices to ensure that all personal property is being properly assessed for the property tax year beginning April 1, 2024. Certain businesses' equipment

may also qualify for the Business Equipment Tax Reimbursement Program ("BETR") and/or the Business Equipment Tax Exemption ("BETE"). See MRS Bulletin Nos. 27 and 28 for more information.

In addition to having general supervisory authority over the assessors in Maine, MRS also serves as an important source of training and guidance for local assessors.
