APPLICATION INFORMATION AND INSTRUCTIONS

Fees for Rider Education School Licenses; this license consists of a Classroom and Range.

The fee for a rider education school license is \$150.00 for each location. Rider education school locations require a classroom and range to be located at the same location and must have a restroom facility. Rider education school licenses one year from issue date.

General Application Requirements

- 1. Submit a letter from the code enforcement officer or other town official that gives the riding school permission to use the facility for rider education. (Initial school application only)
- 2. Submit a letter from your local fire department showing the riding school premises complies with
- state and municipal statutory requirements regarding public health, safety, and access.
- 3. Submit a copy of your Motorcycle Safety Foundation, Rider Education Recognition Program (RERP) agreement.
- 4. Submit proof of liability insurance from the Motorcycle Safety Foundation.
- 5. Submit a copy of your refund/cancellation policy.
- 6. Pass an inspection of the classroom and range premises, including motorcycles, by the Bureau of Motor Vehicles, Rider Education Program.

Recordkeeping and Reporting Requirements

- All school records must be up-to-date and open to inspection upon request.
- All school records must be retained for at least five (5) years and kept at the location indicated on this school license application.
- A new course report must be filed at least seven (7) days prior to the start of the course.
- A course completion report must list each student by name, date-of-birth, phone number, course completion certificate number and e-course certificate number or HW. This report must be filed within seven (7) days of completion of course.

Your application will be reviewed by the Bureau of Motor Vehicles to determine whether you meet the licensing requirements. If your application is approved and after inspections have been completed, you will be issued a license which will be mailed to you. Your license will expire one year from date of issuance. Operating, registering students and advertising a rider education school without a valid license is a Class E crime.

Once you are issued a Rider Education School license it is your responsibility to notify the Bureau of Motor Vehicles in writing of any change in information on the original license application (e.g., change of school name or ownership, address, telephone number, driving or criminal record, employee health, and instructors employed by the school). All correspondence and renewal notices will be sent to the licensee's last known address on file with the Bureau of Motor Vehicles.
