
Plaintiff Darling's Bangor Ford and Defendant Ford Motor Company, by and through their undersigned counsel and pursuant to Rule 54(b) of the Maine Rules of Civil Procedure, have agreed that judgment on Count II, Count III, and Count IV in this matter shall enter in favor of Plaintiff Darling's Bangor Ford and there being no just reason for delay, it is hereby expressly directed and ordered that Separate and Final Judgment shall enter. Ford shall pay a civil penalty to the Maine Highway Department of \$10,000 for each count; Darling's costs, totaling \$1,664.90; and Darling's attorney's fees in the amount of \$17,000.00. All payments shall be made within thirty (30) days of the execution of this Stipulated Judgment by the Board Chair. Where the parties have stipulated to the entry of this Separate and Final Judgment, all rights of appeal are waived, and other than the costs, fees, and penalties awarded above, all costs are waived. Pursuant to Rule 54(b) of the Maine Rules of Civil Procedure, this Judgment

is final and has no effect on the trial, prosecution, and defense of the claims set forth in Count I of the Complaint in the within matter which is currently stayed.
