II. Review and Approve Minutes from November Meeting

III. Discuss Final Draft of Policy Recommendations – Regina

Small group tried to synthesize feedback from last meeting and those offered by email. We did not have the expertise to properly word all feedback. Some of the updating was left for the group as a whole. Any questions/concerns with what is in the latest report, or do you approve?

Education

• Spell out what STEM stands for: Science, Technology, Engineering, and Mathematics.

Economic Security – This section is structured a little different, with a list.

- "Tax deductible" wording may imply that it will cost something, but no better way to word it.
- Add housing to this section. Will also be listed in Safety and Well-Being. Safe, affordable housing for women of all ages. Housing is one of the first keys to economic stability highly dependent.

Health

Add an additional bullet about hunger. Maine leads New England in food insecurity, which
disproportionately affects women and children. "Very low food insecurity" is increasing
dramatically in Maine as well. "Maine should pursue policies that ensure women and
children have access to nutritious food. Potential remedies could include..." Amy will add a
list of current initiatives.

Regina - The last two sections were not discussed at the last meeting. We did get some feedback by email.

Safety & Wellbeing

- Substance of this section agreed upon.
- Reword education section to be applicable to the legislature and governor.
- Cross- reference employment economic security, health impacts, and education.

Leadership and Public Life

- An area the Commission can play a role in: resource to appointing bodies to expand female membership, providing the number of women in various leadership roles, etc.
- Convene in future months to discuss what the roll of a non-partisan group might be in doing this work and what the role of other non-partisan groups might be in moving this forward.

- Agreement that priority should be to produce a brochure and a printed copy of the report.
- All of the funds we accept go through the SOS. Not able to produce 501c3 IRS letters for determination, which foundations will want. What sources are willing to fund given that fact? We have non-profits who are members of the Commission that may be able to accept the money as a 501c3 and pass the money through. Who is the check written out to? Do funders get a receipt?
- How do we go about applying for grants? Can we accept governmental grants?
- Build relationships with funders. Let them know our needs. Early childhood funders
 group meets every month in Portland. Research what other commissions are able to do in
 terms of private foundation funding. Holly will speak with VT Women's Commission
 regarding their funding sources.
- Will schedule another meeting later. Anyone who is interested is welcome to join us.

 - Jen has asked to step down as chair. May have news regarding a replacement at the next meeting.
 - Will work on report roll-out.
