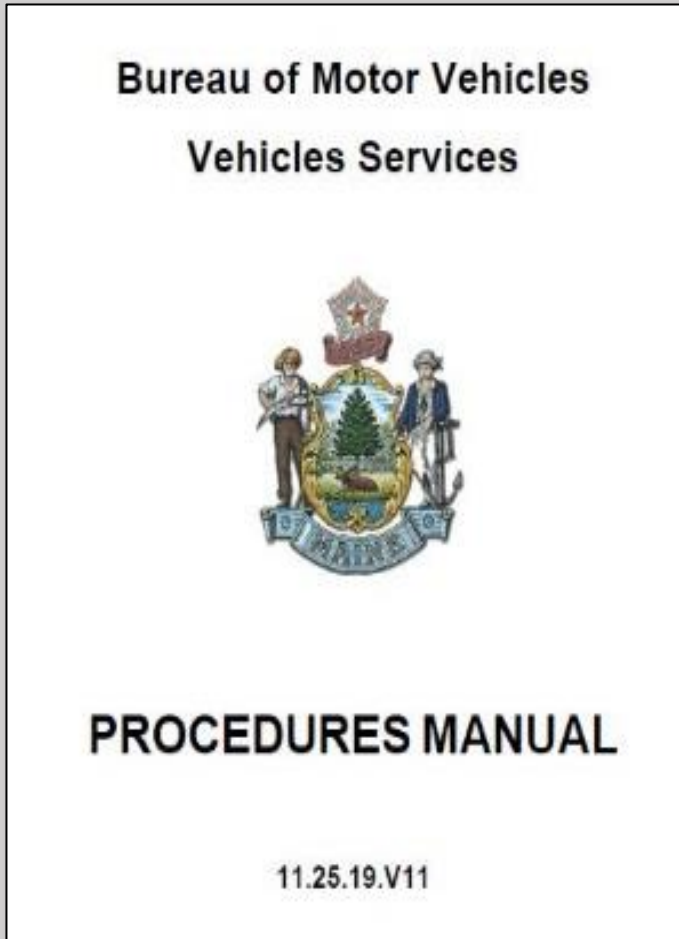

The Procedures Manual will soon be updated and should be kept close at hand and referred to whenever questions about registrations come up.

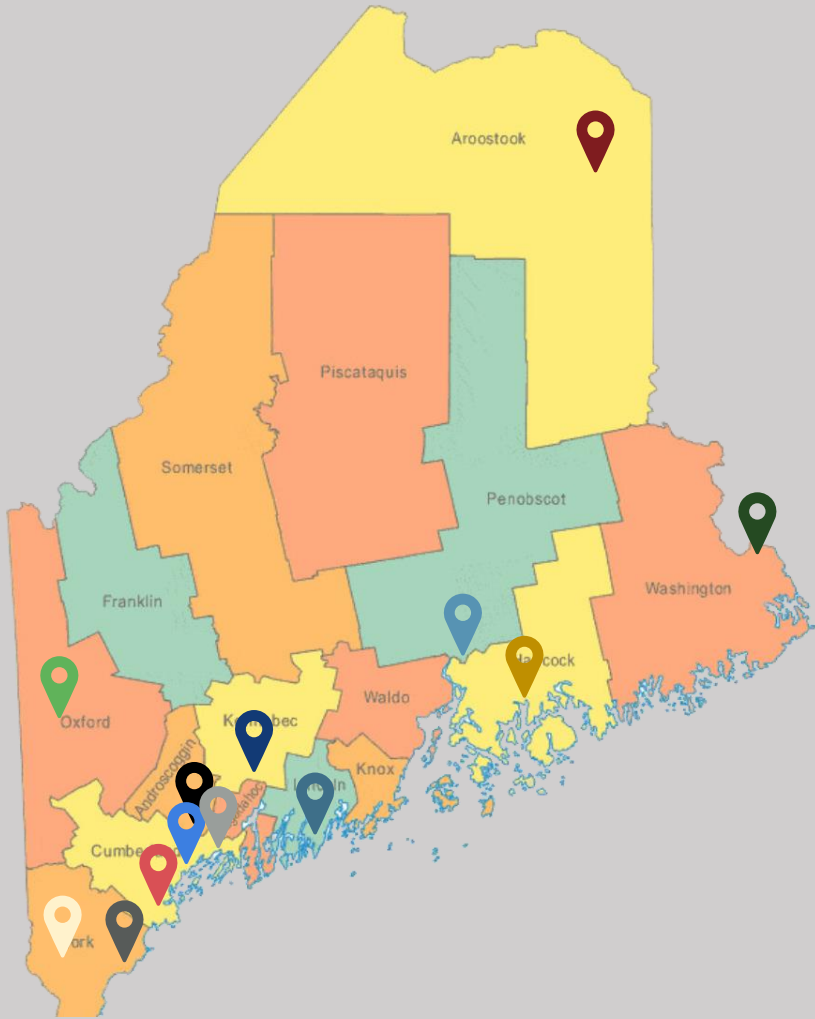

Our Mandate Begins



In 2023 our State Legislature amended the law, **requiring the BMV** to issue a replacement to all Chickadee plates starting May 1, 2025.



Many Chickadee plates are:

- Old,
- In disrepair, and
- Have lost their reflectivity.

What's the Big Deal?

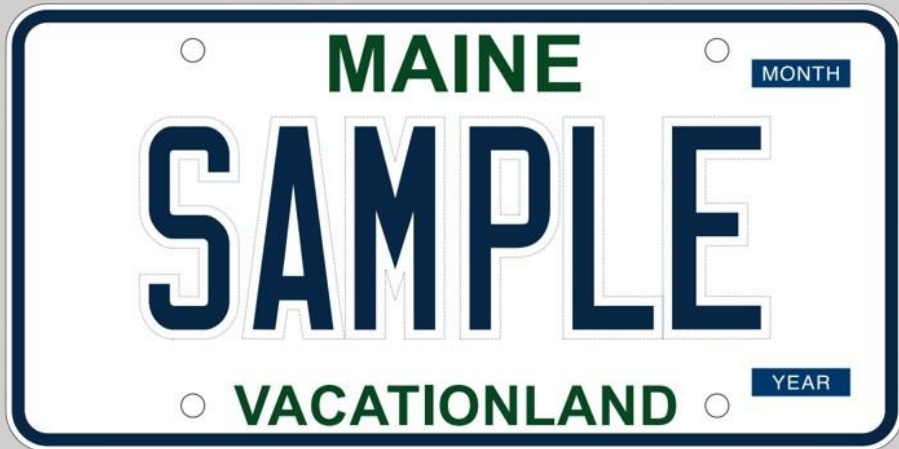
When it begins on May 1, 2025, not a single Chickadee plate **of any class** will be issued from that point forward.



Let's See Those Plates



Pine Tree Plate replacing the Chickadee as the new general issue plate.

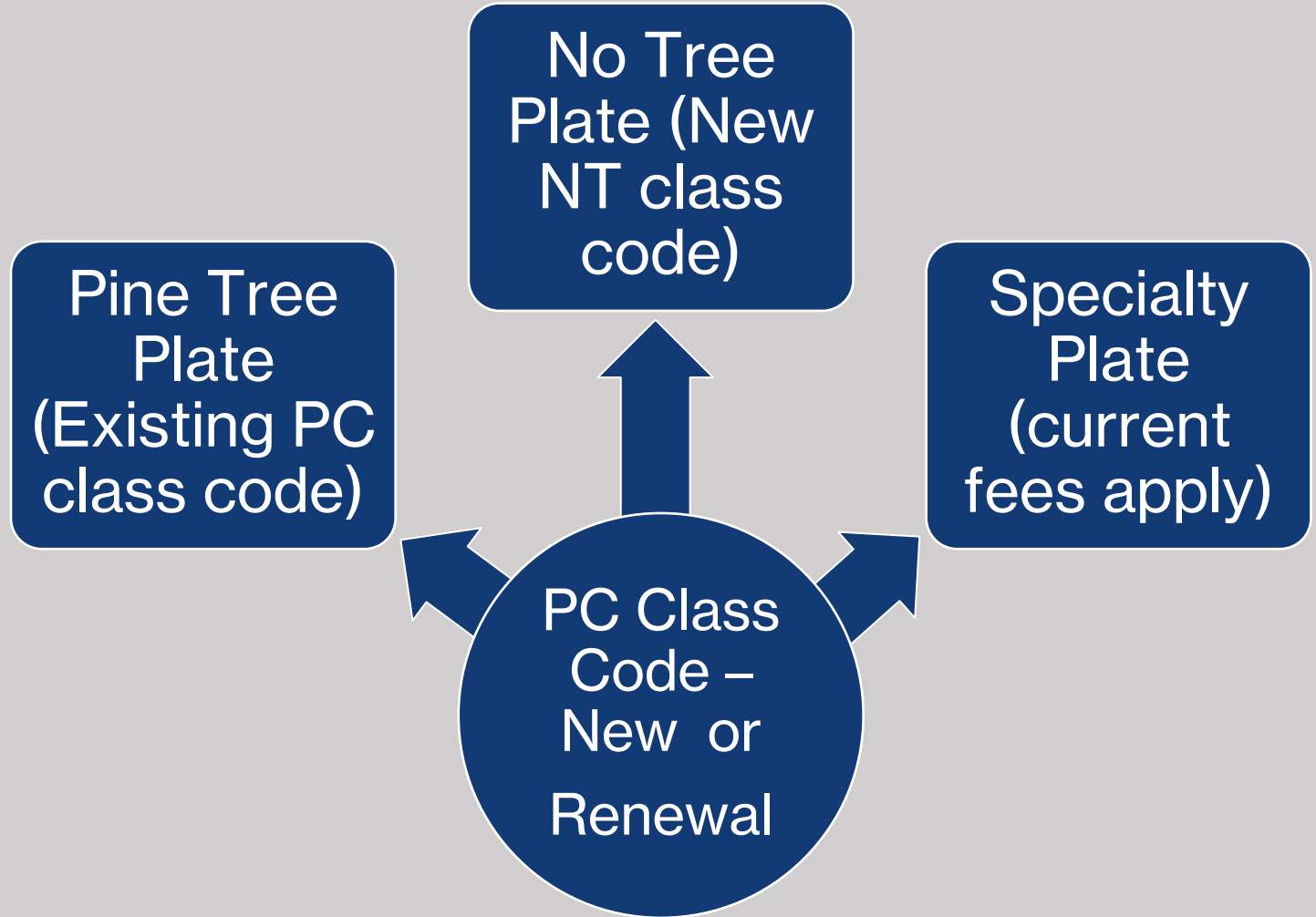


No Tree Plate is an alternative option for the **PC Class Code only.**



PC Class Code Registrants

Registrants with a PC class code, whether new or renewal registrations, may choose to receive the Pine Tree Plate, No Tree Plate, or change to a different style plate altogether. Registrants can also change from other plate styles to the Pine Tree Plate.



→ What You'll Carry



During the issuance, all participating **municipalities** may carry some plate classes outside of their typical authorization level.

Limited New authority towns do not generally carry plate inventory but have been asked to carry plate inventory for renewals during the issuance.

Once the new plate issue is complete in July 2026, Limited New towns will no longer have plate inventory.



What You'll Carry



The BMV has been working with third party vendors (TRIO, MUNIS, NDS) to support these changes.

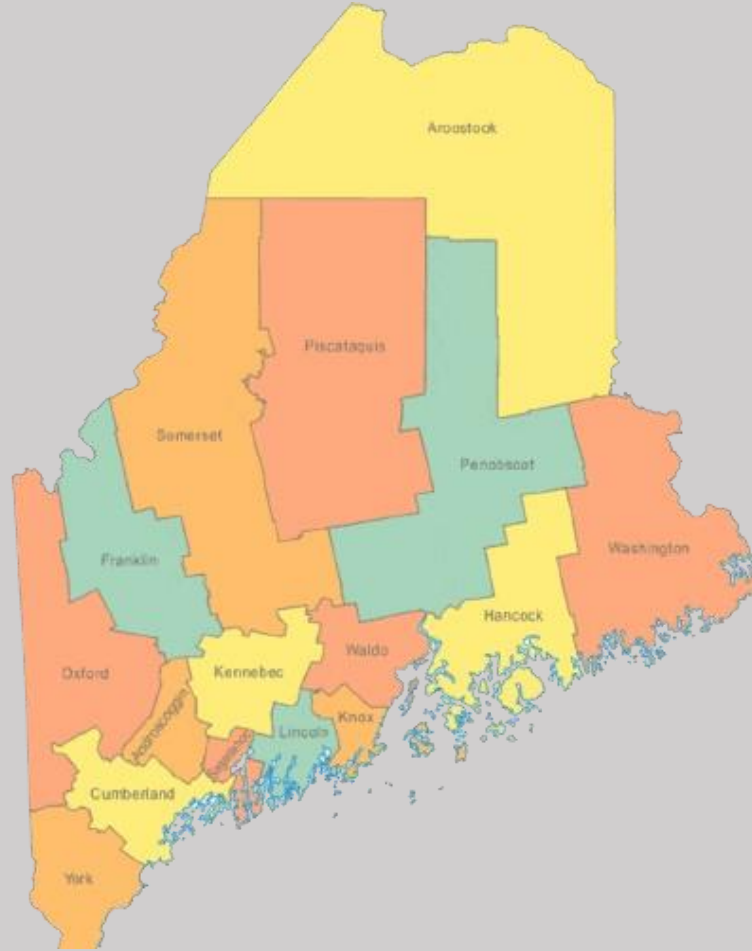
TRIO and Tyler (MUNIS) will offer one live training session. They will record their sessions and make the recordings available to all users. They are also looking into developing some tip sheets.

Northern Data Systems (NDS) will do one-on-one connections with their towns.



What You'll Carry

During NPI, Limited New municipalities will be authorized to carry plates only for the exchange of a customer's existing Chickadee plate.

Limited New Authority

This level **may not** collect Sales Tax fees or Title fees.

New registration transfers – Maine Dealer Only up to 26,000 lbs.

New Registration with Old Plate (NROP) will not be used during the New Plate Issue.
All new registrations and all re-registrations will receive a new plate during the New Plate Issue.

Re-registration transfer – up to 26,000 lbs.

New registration with NEW plate (NRNP) – Maine Dealer Only up to 26,000 lbs.

Name Addition/Deletion (MV-138).

Duplicate registration (MV-11) and Duplicate Stickers (MV-14).

Re-registration with weight changes up to 26,000 lbs.

Re-registration without weight changes up to 100,000 lbs.

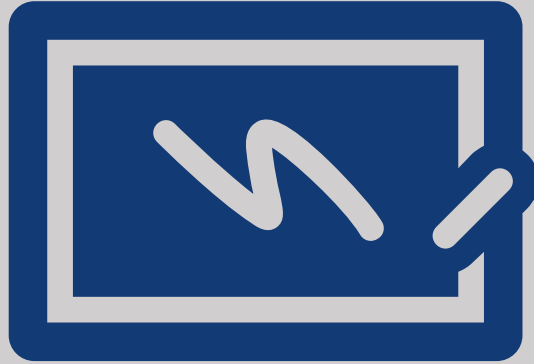
Excise Tax Reimbursement for applicable vehicles registered for over 26,000 lbs.

Transit plates with or without Permit to move to an inspection station.

Special Registration Permits (MVR-10).





















New Numbering Sequences



To avoid duplicate plate numbers across class codes, **starting May 1, 2025**, new numbering sequences will be added to all plates with the Pine Tree design, except DX and TT class codes.

Special Mobile Equipment



Towns will be able to issue an SM plate on a tractor renewal, where the former TR is now an SM.

Preprints for manual towns are already pre-populated with this information (Coded as SM) to help the transition.

Due to the new Special Mobile class code, plate reservations are only allowed for tractors.

These must be manually done, with forms sent to the BMV Administrative Office, Registration section for approval.

Vanities, out-of-rotation plates, and low digit plates will **not be allowed** in the SM class code



→ Special Mobile Equipment (SM)

What is it?

Every self-propelled vehicle not designed or used primarily for the transportation of person or property.

These operate over the highways, including:

- Road construction or maintenance machinery,
- A ditch digging apparatus,
- Stone crushers,
- Air compressors,
- Power shovels,
- Cranes,
- Graders,
- Rollers,
- Trucks used to plow snow.

They also perform other duties pertaining to winter maintenance, including sanding and salting, well drillers, and wood sawing equipment used for hire.

Tractors and SM

1

Road Tractor

Designed and used primarily for drawing other vehicles but not constructed to carry any load.

(Existing Class Code – TR)

2

Farm and Homemade Tractors

Used primarily as a farm implement for drawing plows and mowing machines.

(Existing Class Code – TR)

3

Special Mobile Equipment

Every self-propelled vehicle not designed or used primarily for transportation or property, but which are operated over the highway.

(New Class Code – SM)



→ SM Classes A and B

Currently, Special Mobile Equipment is either processing as a Class A or B tractor but now Special Mobile Equipment will have their own class code.

Special mobile equipment is divided into two classes: **Class A and B.**



SM Classes A and B

Consists of self propelled well drillers and any other special mobile equipment with makes frequent use of the highway.

Well drillers **must be registered** as Class A Special Mobile Equipment.

All other Special Mobile Equipment may be registered as Class A or Class B.

Class A

Class A Special Mobile Equipment is registered for the **actual gross weight (g.v.w.)** of the vehicle.

The registration fee is determined by using the Truck Fee Schedule (MV-60) Special Mobile Equipment Class A Section.



→ SM Classes A and B

Generally, this class makes infrequent use of the highway.

If r.v.w. is over 20,000 lbs., an over limit and/or oversized permit must be obtained prior to each move.

Class B includes all other vehicles that meet the definition but are not listed under Class A, such as cranes, graders, and ditch digging apparatus.

It also includes trucks used only to plow snow and for other duties pertaining to winter maintenance, including sanding and salting.

ELECTRONIC CASH REPORTING

No changes were required of the electronic cash report as the electronic detail report currently breaks out all categories.



Special Equipment (SE)

(Not to be confused with Special Mobile Equipment “SM”)

DEFINITION

Special Equipment (SE) means equipment, other than self propelled, which is not designed or unused to convey property other than hand tools or parts used in connection with the operation of such equipment and which is drawn by a motor vehicle.

EXAMPLES

Air compressors, conveyors, cement mixers, wood splitting or sawing machines, sprayers, brush chippers, etc.

EXPIRATIONS

As you know, all SE registrations have a mandatory February expiration. They also have an optional two-year registration.

Registrations expiring in February 2025 will need to renew but registrants will not receive the Pine Tree because they cannot be dispensed before May 1st, 2025.

REGISTRATIONS

In Summary, nothing is changing.

1-year SE registrations will process with a chickadee plate and registrants will receive the Pine Tree in February 2026.

2-year renewals will also process with a chickadee plate and will be switched out by the BMV Administrative office prior to the completion of NPI in July of 2026.



→ Disabled Motor Home (WX)

DEFINITION

During New Plate Issuance, Disabled Motor Home (WX) plates are being entirely discontinued. These have not been offered in several years, but customers were previously able to keep their existing WX plates. Customers will not be able to reserve their current WX plates as they are being phased out entirely.

REPLACEMENT

If a customer comes in to renew a WX plate, please provide them with a Motor Home (MH) plate to replace their current WX plate.

The BMV has already verified that all current WX plate holders have an active placard. Registrants have also been notified of the change to the MH plate and the active placard.

Registrants who would like to keep their current Chickadee plate numbers may reserve their plate for a \$25 one-time fee.

Registrants who have an active vanity, low digit, and National Guard (PC class code) **must reserve their plates** if they would like to keep their current plate number.





Plate Number Reservations

A license plate number can be reserved in **four different ways**.

Note: The four avenues to reserve do not have an expiration date and will be available throughout the new plate issue.

Plate Number Reservations

Option One

Online through a standalone reservation portal (maine.gov/online/reservemyplate).

This option is only available **until 30 days prior** to a registrant's month of expiration. For example....for an August renewal, this portal would only be available until July 1, otherwise, one of the other 3 options must be used.

They will be prompted if they use the Rapid Renewal website.

Option Three — — — → Going into a BMV branch office.

Option Four — — — → Mailing in a Reserve Plate Application (MV-62) to the BMV Administrative Office.
This is **required** for TR reservations.



Plate Number Reservations

Class codes that can be reserved are:
AQ, BU, CM, CO, CV, DX, FM, HC, LS, MH, NT, PC, SE, SR, TT and TX.

Non-chickadee plates **will not** have the option to reserve.

The NT plate class **can only be reserved** if the registrant has a PC plate currently.

No other plate classes have the option to select the NT plate class.

Tractor plates (TR) may only be reserved through the manual application process **(MV-62)**.

All municipalities have been mailed **25 Reserve Plate applications (MV-62)** to share with customers and can order more from the stockroom as needed.

Early Renewals

To ensure all chickadee plates are replaced by the new plate design, we are instructing you to **not process any early renewals** for registrations with expiration dates of **May 2025** through **December 2025** until May 1, 2025, for any registration with a chickadee plate class code.

Vanity | Out-Of-Rotation | Low Digit | National Guard

Registrants who would like to keep their current chickadee plate numbers may reserve their plate number for a **one-time \$25 fee**.

Current registrations with Vanity, Out of Rotation, Low Digit and National Guard plates **must reserve their plate** if they would like to keep it.

BMV mailed postcards to registrants with active Vanity, Out of Rotation, Low Digit and National Guard with information on how to reserve their plates in 2024 and will mail two more reminders in 2025.

Registrants also may reserve if they simply like their current plate number.



Vanity Plates

Vanity plates are being issued using the following guidelines that are **best practice** to ease the transition to the Pine Tree and No Tree plates:



- A Pine Tree (PC) vanity plate can have up to seven characters **including a space or a dash**.
 - Seven characters plus a space or a dash would cover the image of the Pine Tree.
- A No Tree (NT) vanity plate can have up to seven characters **plus a space or a dash**.

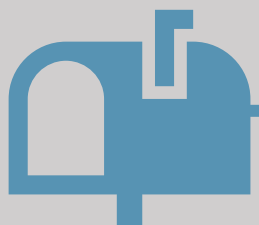

Reserved plates will be mailed **directly to the customer.**



Reserving their plate number guarantees to them that they will receive their plates **two to four weeks prior** to their registration's month of expiration at their address.



Customers will come into the municipality with **their new plate they received in the mail, their reservation letter from BMV**, and municipalities will re-register with the new plate.

Reservation Letter

Customers will receive their reserved plate in the mail, and they MUST come in with their physical plate in hand to complete their registration.

We are instructing customers to bring their letter in with them, but municipalities do not need to collect the letter from the customer, and you are not required to append it to your cash reporting.



Electronic Processing Municipalities

Preprint

Preprint Data: In place of paper preprints, electronic municipalities will have their preprint data posted electronically to the InforME website approximately six weeks prior to the effective date.

To ensure that municipalities' registration records are kept as up-to-date as possible (including any suspension information); **this data must** be loaded into the electronic system.

- Manual municipalities will use preprint, if available, or type a new registration stating “No Preprint” on the registration and **highlight with yellow highlighter**.
- The **prior plate class code and plate number** will be printed on the pre-print registration in the print priority area.
- There will be a *print phrase* of ‘**Resrv # Fee Pd**’ on manual pre-prints if the plate has been reserved. *Note: Electronic records will have the same **Resrv # Fee Pd** print phrase.*
- If a manual town is unable to use the pre-print, the municipality will need to add the **previous class code and plate number** on the registrations created when they are unable to use the pre-print.

Re-Registration Processing

Summary

A signature is not required on a re-registration.

Manual municipalities will use preprint, if available, or type a new registration stating “No Preprint” in the space provided on the registration and **highlight with yellow highlighter**.

Verify insurance and confirm the registrant is not required to file an SR-22.

Then, review the initial registration form and **verify the current information** on the registration including plate number prior to renewing.

Confirm if the plate number was reserved or not. If yes, customer will have plate and letter in hand.

If no, municipality will pull the next Pine Tree plate or No Tree plate off the shelf.

Collect all fees, validate the registration certificate (**white and yellow copies**) and give the customer the yellow copy with stickers attached.

Retain the pink copy for your municipal records and send the white copy to the BMV Administrative Office with your cash report.

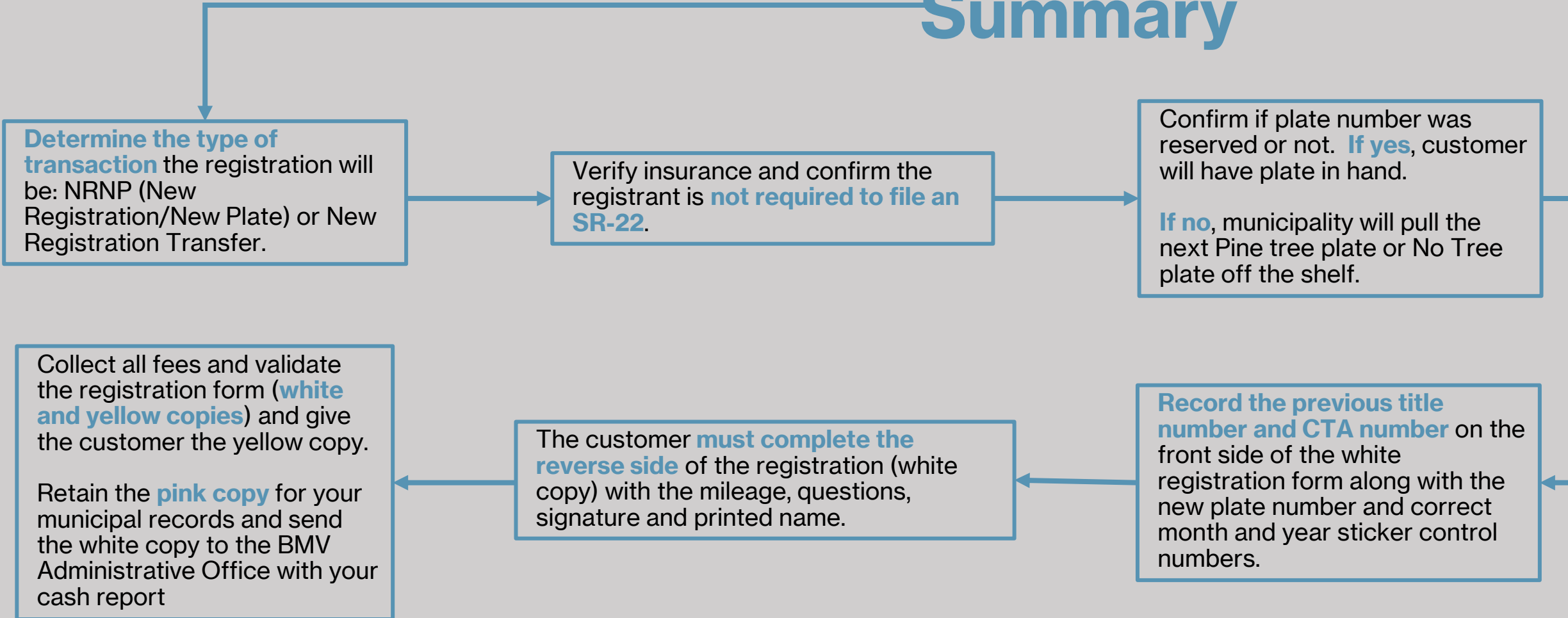
The customer **must complete the reverse side** of the registration (white copy) with the mileage and questions.

Questions 1 & 2 **must be answered** on all registrations, including re-registrations and trailers.

Record the new plate number and the sticker control numbers in the space provided on the registration form.



New Registration Processing Summary



Lost Plates

Customers may lose their physical Chickadee plates during this NPI process. The cut-off for ordering a lost Chickadee plate the traditional way was **March 31st, 2025**.

If customers simply want new plates off the shelf, the process does not change.

- Issue a random set of chickadee plates if the request is prior to May 1st., the fee is \$11.00 (\$5.00 for each plate and \$0.25 for each sticker).
- OR
- Provide the registrant a lost plate application, MV-9. Instruct them to either submit via the mail or go in person to a branch office.

Stickers

Each registration that receives a new plate during the general plate issue will **need to receive a set of month and year stickers** i.e. single or double.

Month and year **double** stickers for all class codes will be on an **automatic shipment process** from the Bureau of Motor Vehicles Administrative Office to your municipality's listed inventory shipping address during the new plate issuance year.

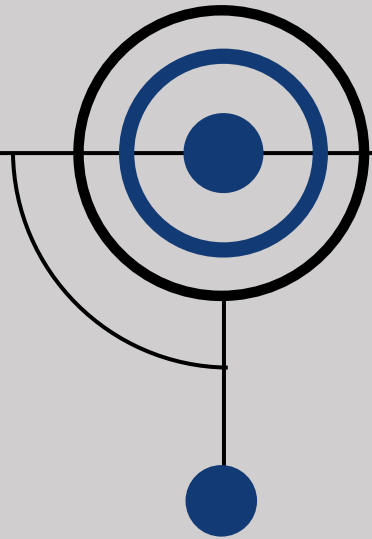
The **first shipment will be in March/April 2025** and will contain the estimated amount of May/June double stickers necessary to get started. Then **each month thereafter**, a supply of **double** stickers will be sent based on your prior years processing data.

Municipalities will need to **continue ordering single stickers** as you do today through the stockroom using the MV-51 (Trailer, Motorcycle, Special Equipment).

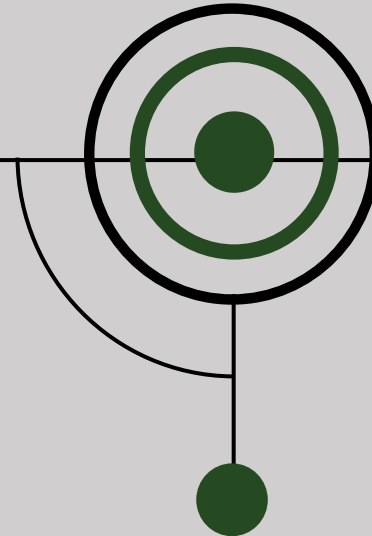
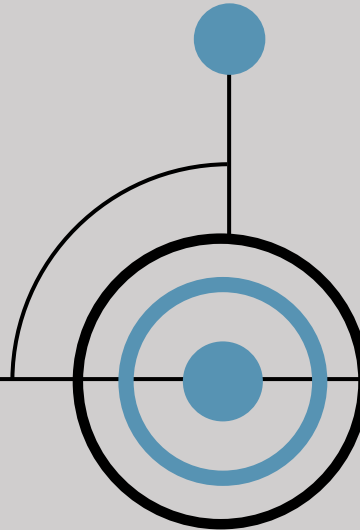

Plate Delivery

The Pine Tree plate and No Tree plate delivery for municipal offices will be automated based on prior years' data averages.

Automated shipments of plates will begin in March/April 2025. **The initial start-up supply** will account for a minimum of two (2) months stock of registration plates based on standardized packaging.

Shipments will continue monthly until the calculated threshold of total plates is reached for each municipality.

If a location reaches their full quantity in the first shipment additional plates will **not be mailed**.



→ Additional Plate Orders



If an unanticipated need for plates should arise due to an increased demand,
please reach out to the BMV Stockroom.

Specialty Plates will continue to be available at **New and Truck Level municipalities, as well as BMV Branch Offices.** Order processing for these plates is not changing, currently.

Return Plates

Chickadee Plates



Instead of asking you to take your **unissued** chickadee plates to the nearest BMV Branch Office, we will provide you the means to return the plates to the BMV Stockroom. This process applies to ALL municipalities.

Following are the process steps for returning them to the BMV Stockroom:

- All towns will email the BMV Stockroom at NPISockroom.BMV@maine.gov between May 5, 2025, and May 9, 2025, with the count of all their unissued chickadee plates.
- The BMV Stockroom will create a pre-paid UPS sticker and give it to UPS between May 6, 2025, and May 16, 2025.
- The town will box up the unused chickadee plates.
- UPS will pick up the box and will apply the pre-paid sticker on it and deliver to the BMV Stockroom.

Note: Only metal plates should be placed in the box(es) for recycling. No paper, registrations, MV-553, plastics or miscellaneous items either individually or attached to plates should be in the box.

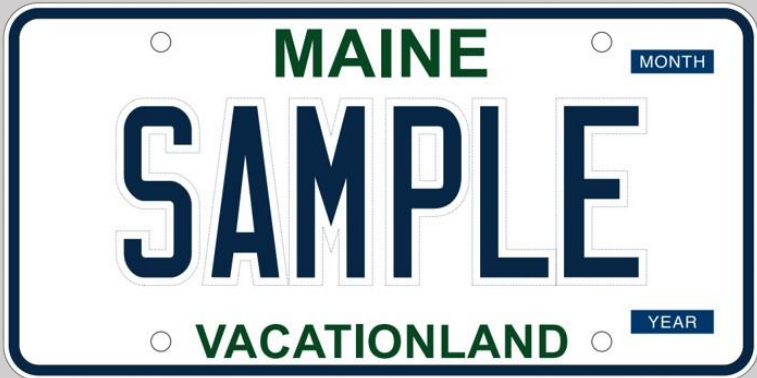

Unused NPI Inventory

Unused new plate issuance plates will be retrieved at the conclusion of the general plate issue period.

The retrieval process is currently **scheduled to begin July 2026**. More detailed instruction will be provided closer to that date.

Transmittals

Receipt of transmittals will occur in **one of 2 ways**:

- Firstly, via an email. Automated plate shipments from Waldale will generate an e-mailed notice containing the transmittal to your listed e-mail address prior to the delivery of the plates. **Verify the amount and proper ranges on the transmittal to the physical shipment** before returning the verified and signed transmittals to BMV.
- The second process will mirror **the current practice** for specialty plate orders from the plate shop. The transmittal document will be within the packaging of the physical shipment of stickers and specialty plate orders.

Transmittal information **should be verified to the physical inventory received from BMV**. If the amounts are correct the transmittal should be signed, marked as received and returned.

If the amounts are incorrect, mark the exceptions box and make the appropriate notes **to detail the exception(s)**.

BMV will email individual plans to each town. The plan contains new and renewed registration quantities per:

- Class Code,
- Town,
- Month and
- Factors like the volume of plates a town issues on behalf of another town.

The **first plate shipment** will consist of May and June volume and will be delivered in March.

All subsequent shipments will contain volume for one month.

For example, your inventory for July will ship in May.

Another would be August's inventory shipping in June.

Pine Tree and No Tree plates will be shipped directly to municipalities from Amherst Nova Scotia.

New Plate Issue sticker volume **will be on automatic shipment** from the BMV Stockroom to your municipality's listed inventory shipping address during the new plate issue year.

Being ready for when rubber hits the road.

Overview

INFORMATION:

Municipal Agents may contact their BMV Municipal Coordinators at 1-207-624-9000, extension 52163.

Low Digit: is any registration plate with four digits or less without a letter or two digits or less followed by a single or double letter.

Low digit plates include:

- 1-9999 without any letter following.
- 1-99 with a single letter following.
- 1-25 with double letters following.

These plates **may be obtained only through the Secretary of State's Office** and carry an additional one-time fee, of \$25.00 over and above the regular registration fee.

If the plate was issued prior to May 1, 2025, the fee was \$25.00 for the issuance of the low digit plate in the chickadee design. The plate would be subject to an additional one-time \$25.00 fee to reserve the same number in the new pine tree design.

Upon first time registration of a low digit plate, the customer must present a letter from the Secretary of State stating the customer's name and plate number issued. The customer may reregister or transfer credit in their name only, unless given written permission from the Secretary of State to add their spouse.





Overview



REMEMBER: Do not add or delete a name on any low digit plate registration anytime during the registration period – **UNLESS you have written permission from the Secretary of State's Office.**

It is the policy to permit the transfer of low digit plates from one spouse to another, but in each case, **written authorization of the Secretary of State is required.**

Registrations for low digit plates not issued in accordance with these guidelines **will be revoked.**



Overview

OUT OF ROTATION: A registrant may select a number out of rotation for a fee of \$25.00. This fee is applicable when:

- a. The registrant wants a unique number that must be pulled or manufactured out of sequence from current, valid series within the class code.
- b. The registrant wants a number that has been previously issued, is no longer in use, and must be reprinted.
- c. The registrant wants a low digit (as defined in the low digit plate section) and has the plate and the appropriate letter from the Secretary of State's Office.
- d. The out-of-rotation fee will be applied in those cases where the plate(s) is/are in your office. Please note that record-keeping requirements must be met in all cases.

Example: You have the following range of PC plates in your office: 251KTA-500KTA. The customer wants 400KTA. If you issue that plate to him at that time the \$25.00 Out of Rotation fee would apply.

SCENARIOS

NOTES: Regarding these scenarios; certain facts are standard for each scenario, even if it is not specifically stated in the scenario:

1. The new plate issue may be referred to as '**NPI**' within the text of this document.
2. Excise tax is paid to the municipality of legal residence prior to processing a renewal or new registration transaction.
3. The registrant always has the option of completing the transaction at a Motor Vehicle branch office after payment of excise tax.
4. Agreements between neighboring municipalities are not assumed. You must verify that they are willing to process new registrations or trucks level transactions for your residents.
5. Municipalities may process only those transactions within their current level of authorization.



Overview

SCENARIOS

1. Transactions currently restricted, remain restricted, i.e., suspended registrations. The SR-22 requirement of calling or emailing for permission remains an option to process.
2. The instructions listed below are an overview or reference tool rather than a detailed processing document. As a municipality, your processing will be specific to your program (manual or electronic), templates, and authorization level. Motor Vehicle Offices will have unique guidance documents.
3. If you have questions, please ask. For many of you, this is your first plate issue, you are not expected to know all the answers. Ask the question(s). Questions should be directed to the **Administrative Office at 1-207-624-9000**, extension **52163** for Municipal Coordinators. Time allowing, you may also send questions to Municipal.BMV@maine.gov



Scenarios

- 1** A person wants a pine tree plate with a number from a plate that their next-door neighbor has on a vehicle.
- A. Limited:** Unable to process the request.
 - B. New & Truck:** Same answer.
 - C. Branch:** Same answer.

- 2** Herbert wants to reserve the number that he currently has on his conservation plate.
- A. Limited:** The Conservation plate numbers are unique to that class code. They do not translate nor are they transferable to the pine tree plate issue. Herbert therefore cannot reserve. He may be able to obtain an out-of-rotation number that is similar but not exactly the same.
 - B. New & Truck:** Same answer.
 - C. Branch:** Same answer.



Scenarios

3

It is May 2025. A registrant wants to use a plate (PC) 8288 that their friend just gave them.

- A. Limited:** Not immediately. The plate must be authorized by the Secretary of State's Office, and the request should be in writing. The Secretary of State will respond. And, if use of the plate is approved, the registrant will receive a letter of instructions, a copy of which must be submitted at time of processing. Fees apply. See Low Digit Plate policy in the procedures manual.
- B. New & Truck:** Same answer.
- C. Branch:** Same answer.

4

It is June 2025; Wilson has two vehicles, and he reserved both sets of plates. He already has one set of pine tree plates on a vehicle with a May 2026 expiration date.

His other vehicle expires in December 2025. He wants to put the May plate on the December vehicle and the December plate on the May vehicle.

- A. Limited:** The plate change may not be processed at this time. In December 2025, the change may be processed.
- B. New & Truck:** Same answer.
- C. Branch:** Same answer.



Scenarios

5

Prescot has a set of pine tree plates (PC) 651-KTA on a vehicle with a May 2026 expiration date, Vehicle A. He comes in June 14, 2025, to do a class change to a new commercial plate for 27,000 pounds.

Then he wants to put the passenger plate 651-KTA on Vehicle B that has a March 2026 expiration date.

- A. Limited:** Unable to process this transaction at this authorization level. Send registration to a neighboring Truck level municipality that will process for the residents of your municipality or a branch office.
- B. New:** Same as Limited.
- C. Truck:** Indicate a “corrected registration” with a “Plate & Class Change PC-651-KTA” in the appropriate area on the registration. Remember to indicate the registered weight on the registration and issue the proper month and year stickers. There may be an IGW fee due. The passenger plate may not be put on the vehicle with the March expiration until time of renewal.
- D. Branch:** Same as Truck.



Scenarios

6

Erin comes in June of 2025. She would like to have the same number on her pine tree plate. Her vehicle expired May 2025, and she did not reserve.

A. Limited: Have Erin decide if she would like to:

- A. Reserve and renew an on-line if your municipality participates in Rapid Renewal. She will receive one package with her plates, stickers, and registration. She will continue to display her chickadee plates until the pine tree plate is received.
- B. Collect the excise tax only and go to a branch office to complete the registration and reserve her plate number. She will continue to display her chickadee plates until the pine tree plate is received.
- C. If she decides not to pursue the reserve plate, complete the registration assigning the next available pine tree plate.

B. New & Truck: Same answer.

C. Branch: After proof of excise tax payment, follow standard procedures by completing the transaction, updating the registration, and reserving the number in the system. Provide the customer the completed registration and stickers. Forward the validated materials and a copy of the renewed registration to the Administrative Office. The reserve plate will be mailed under separate cover directly to the registrant. She will continue to display her chickadee plates until the pine tree plate is received.



Scenarios

- 7** Registrant comes in August of 2025 to register a newly purchased vehicle from a Maine dealer. They traded their old vehicle which would have expired April 2026. They want to get their same number for the pine tree plate They did not reserve their plate.
- A. Limited:** Collect the excise tax either as a transfer or new registration.
- A. As a transfer: give the registrant the option to complete the transaction at your office or a branch office. Advise the customer they may reserve their number via the on-line portal if completing the transfer at your office. If completing the transfer at a branch, they may reserve at that time. Note: They will receive the pine tree plate for their April 2026 renewal.
 - B. As a new registration: Collect the excise tax only and send to the closest branch office for completion. The plates will be printed and mailed directly to the registrant. The registrant will continue to display their chickadee plates until the pine tree plate is received.
- B. New & Truck:** Same answer.
- C. Branch:** Complete the transaction, provide the validated registration & stickers, enter, and process the reserve.



Scenarios

8

Registrant comes in August of 2025 to register a Maine dealer purchased automobile as a new registration (*not a transfer*). They have reserved their plate number and the registration for their trade-in vehicle expires: **(A)** July 2025; **(B)** October 2025; or **(C)** March 2026.

For (A):

- A. Limited:** Pull the preprint form or delta file data, verifying the plate number was reserved and received by the customer.
 - A. Option 1 – Process the new registration using the reserved plate. Indicate on the registration that the plate was reserved.
 - B. Option 2 – Collect the excise tax, allow the registrant to complete the transaction elsewhere.
- B. New & Truck:** Same as above.
- C. Branch:** Complete the transaction upon proof of excise tax payment.

For (B) & (C):

- A. Limited:** If the registrant has not received their plate, collect the excise tax, and send the customer to a branch office.
- B. New & Truck:** Same as above.
- C. Branch:** After proof of excise tax payment, follow standard procedures by completing the transaction, updating the registration, and reserving the number in the system. Provide the customer the completed registration and stickers. Forward the validated materials and a copy of the renewed registration to the Administrative Office. The reserve plate will be mailed under separate cover directly to the registrant.



Scenarios

9

Brock has an April 2026 expiration date and has not reserved his plate number. He loses one plate. He comes in April 20, 2025, and wants his same number in the chickadee. He does not want to reserve; he does not like the design, nor does he want the pine tree plate now or in the future.

- A. Limited:** Provide the registrant a lost plate application, MV-9. Instruct him to either submit via the mail or go in person to a branch office or a neighboring town that you have an agreement to process. A photocopy of his current registration and a \$5.00 fee for each missing plate and \$0.25 fee for each sticker should be included if mailing the application. Inform the registrant that he will not be receiving the chickadee plate number, as the cut-off date for printing of chickadee plates was March 31, 2025.
- B. New & Truck:** Issue a random set of chickadee plates if he will accept the different number, the fee is \$11.00 (\$5.00 for each plate and \$0.25 for each sticker). Inform him that chickadee plates are no longer being printed as of March 31, 2025. Therefore, we are unable to fulfill his request for the same number in a chickadee.
 - A. Second option, go to a branch office to complete the transaction.
- C. Branch:** Issue a random set of chickadee plates if he will accept the different number, the fee is \$11.00. Requesting the same number in chickadee is not an option, as of March 31, 2025, chickadee plates will cease production.

Note: Lost plates ordered and validated prior to March 31, 2025, will be printed as chickadee plates. This is a hard stop on chickadee plates as of March 31, 2025.



Scenarios

- 10** Customer has a March 2026 expiration date and has not reserved their plate number. They lose one plate. They come in after May 1, 2025, and want to order the lost plate. They do not want to reserve, nor do they care about the number. Their plate number is (PC) 7398BO.
- A. Limited:** Provide the MV-9, lost plate form with instructions to either go to a neighboring town that you have an agreement with, a branch office, or mail with a copy of the registration and \$11.00 fee (\$5.00 for each plate and \$0.25 for each sticker) to the address on the form.
 - B. New & Truck:** Provide a MV-9 for the customer to fill out. Collect the \$11.00 plate and sticker fee (\$5.00 for each plate and \$0.25 for each sticker). Assign a new pine tree plate and complete the lower portion of the MV-9. Type a corrected registration indicating the “Plate Change, PC-7398BO”. Remember to issue and record month and year stickers. Ask the registrant to return the remaining chickadee plate, complete the MV-553 return plate card.
 - C. Branch:** Same as New & Truck.



Scenarios

- 11** Bailey has lost both of her (PC) plates due to an accident on Friday May 13th and comes into your office on the 16th of May. Her registration is valid until September 2025, and she wants to replace the missing plates. The original number has not been reserved.
- A. Limited:** Be sure Bailey has a copy of her current registration, provide her with the lost plate form (MV-9) and send her to a branch office or neighboring town willing to process for your residents.
 - B. New & Truck:** Complete the MV-9. Issue the next set of pine tree plates replacing the prior chickadee plates. The fee will be \$11.00 for the plates and stickers (\$5.00 for each plate and \$0.25 for each sticker). Issue Bailey a corrected registration indicating the plate change and issue and record the proper month and year stickers. If she wants to retain the same number, she must go to a branch office.
 - C. Branch:** Complete the MV-9. Determine if this is to be a reserve or random plate issue. The fee for the lost plate and stickers is \$11.00 for the next available plate. If Bailey wishes to retain the same plate number process as a reserve for the \$25.00 instead and complete the MV-62. Issue a temporary plate.
 - A. Note:** *this is the only temporary plate scenario because both plates have been lost.*



Scenarios

12 Jordan has a February 2025 expiration, and she did not renew. She comes in after May 1, 2025, to renew. She insists on getting the pine tree plate and does not care about the plate number.

A. Limited:

- A. Option 1 – Renew the registration with the chickadee plate. Jordan will have to wait until February 2026 for her pine tree plate.
- B. Option 2 – If she insists on getting her plate now, renew the registration, collect an additional \$11.00 lost plate and sticker fee (\$5.00 for each plate and \$0.25 for each sticker) and issue the next available pine tree plate.

B. New & Truck: Same answer.

C. Branch: Same answer.



Scenarios

- 13** Geno has a February 2025 expiration. He comes in on or after May 1, 2025, to renew. He insists on getting the pine tree plate now, and he wants the same number as his chickadee plate.
- A. Limited:**
- A. Option 1 – If the municipality participates in Rapid Renewal, he may renew and reserve his number on-line. The reserved number will be mailed to him for February 2026.
 - B. Option 2 – Renew the registration. Geno will have to wait until February 2026 for his pine tree plate. He can reserve his number at the Informe Stand Alone Reservation Portal once the renewed registration is updated by BMV.
 - C. Option 3 – After renewing he may go to a branch office or mail a copy of his renewed registration, a MV-62 and the \$25.00 fee to BMV.
 - D. Collect excise tax only and he may complete the entire transaction at a branch office.
 - A. NOTE: NPI is connected to the expiration date not the request date.
- B. New & Truck:** Same answer.
- C. Branch:** Complete the registration and forward the reserve application materials to the Administrative Office per current procedure. Geno will continue to display the chickadee plate until he renews for February 2026.



Scenarios

- 14** Charles has a March 2025 expiration. He comes in on or after May 1, 2025, to renew. He would like a vanity plate to replace his current number plate.
- A. Limited:** There are three options.
- A. Option 1 – After renewing and once his renewal data is updated by the Bureau of Motor Vehicles, Charles may check availability and order a vanity plate upon payment of the \$25.00 fee via the on-line BMV vanity plates portal. The vanity plate will be mailed to him, and it will be a pine tree plate or no tree plate for all three options.
 - B. Option 2 – Send Charles to a branch office to complete his request after he pays excise tax.
 - C. Option 3 – Renew the registration. Have Charles submit a copy of the registration, a vanity plate application, and the \$25.00 fee to the Administrative Office for processing.
- B. New & Truck:** Same answer.
- C. Branch:** Complete the transaction, accept the vanity plate application, and fee, and forward the material as normal. Provide the customer with stickers and a validated registration of his current chickadee plate number. A corrected registration and new stickers will be mailed along with the vanity plate when manufactured.



Scenarios

15 Joe comes in August of 2025 to register a new vehicle. He traded his old vehicle for the new truck at a Maine dealership. The former truck would have expired April 2026 with 16,000 GVW and he did not want to reserve his old plate.

- A. Limited:** Process the registration issuing the next available pine tree plate if it is a new registration going for a full year. If he wants to process a transfer, then process the registration using the April expiration date, retaining the chickadee plate until renewal time.
- B. New & Truck:** Same as above.
- C. Branch:** Same as above.

16 It is May 1, 2025. Kyler has a conservation plate on her vehicle that has a February 2026 expiration date. She would like to surrender the plate and get the new pine tree plate.

- A. Limited:** Refer this registrant to a neighboring town at the New/Truck level that will process for your residents or a branch office.
- B. New & Truck:** Have Kyler surrender her conservation plate, issue the next random pine tree plate. This is a correction and should indicate the plate change information of the prior plate number and class code and remember to issue the same month and year stickers as your current registration. Complete a MV553 on the returned CR plate.
- C. Branch:** Process the plate change request using current procedures.



Scenarios

- 17** On July 15, 2025, Derek comes in to renew his horseless carriage. **(A)** He has reserved his plate and has it with him. **(B)** He did not reserve and does not want to reserve.
- A. Limited:**
- A. Because Derek has his plate, pull the preprint or delta file record for notations. Complete the renewal process issuing the reserved HC class plate.
 - B. Collect excise tax only and refer Derek to contact the Administrative Office for additional processing instruction on his HC class renewal.
- B. New & Truck:** Same as above.
- C. Branch:** Verify the excise tax receipt. Call the Administrative office for the next available plate number and complete the transaction with a temporary plate. Issue the registration and stickers to the registrant, the plates will be mailed to them.



Scenarios

18

It is June 12, 2025. Sam has a low-speed vehicle plate (LS) on his vehicle that has a June 2025 expiration date. He is here to renew: **(A)** he has reserved his plate and has it with him; **(B)** he did not want to reserve.

A. Limited:

- A. Because Sam has his plate, pull the preprint or delta file record for notations. Complete the renewal process issuing the reserved LS class plate.
- B. Collect excise tax only and refer Sam to a branch office to process his LS class renewal.

B. New & Truck: Same as above.

C. Branch:

- A. Verify payment of excise tax and process.
- B. Verify payment of excise tax and issue the next available pine tree LS plate.
 - A. *Note: A similar process will be followed for class codes BU, SR, and TX, as with LS.*



Scenarios

19 It is August 19, 2025. Daniel has a tractor trailer truck (TT) with a June 2025 expiration date. He is here to renew: **(A)** he has reserved his plate and has it with him; **(B)** he did not reserve.

A. Limited:

- A. Because Daniel has his plate, pull the preprint or delta file record for notations. Complete the renewal process issuing the reserved TT class plate, making sure question #6 on the reverse side of the white registration is marked appropriately. Follow the proper processing procedures for a 'big truck'.
- B. Issue the next available TT pine tree plate following proper processing procedures for a 'big truck'.

B. New: Same as above.

C. Truck:

- A. Because Daniel has his plate, pull the preprint or delta file record for notations. Complete the renewal process issuing the reserved TT class plate, making sure question #6 on the reverse side of the white registration is marked appropriately. Follow the proper processing procedures for a 'big truck'.
- B. Following proper processing procedures, assign the next available pine tree TT plate.

D. Branch:

- A. Verify payment of excise tax and process.
- B. Verify payment of excise tax and issue the next available pine tree TT plate.



Scenarios

- 20** It is May 1, 2025. Browning has a special mobile equipment class A well driller (TR) with a June 2025 expiration date. He is here to renew and wants to reserve his plate.
- A. Limited:** He will not be allowed to reserve the TR plate with this vehicle type. He will not be mailed a plate. Pull the preprint or delta file record for any notifications. Assign the next available new SM pine tree plate. Complete the renewal process, remembering to use the new SM class code and appropriate print phrase.
 - A. Note: The new SM class plates have a unique number sequence, and reservations of old TR class code numbers are not an available option.
 - B. New & Truck:** Same as above.
 - C. Branch:** Same as above. The Administrative Office will rebate on a reserved TR plate if processed in error.

Note: Be sure to issue the correct stickers and inform customer not to display them until June 1, 2025.



Scenarios

- 21** It is May 1, 2025. Justin has a passenger plate on his vehicle that has a May 2025 expiration date. He is here to renew and does not wish to keep his current number.
- A. Limited:** Determine if Justin wants a PC or an NT plate. Pull the preprint or delta file record for any notations. Complete the renewal process issuing the next available number of the chosen class code.
 - B. New & Truck:** Same as above.
 - C. Branch:** Verify excise payment and complete based on Justin's preference of PC or NT.

- 22** It is August 19, 2025. Easton has a new grader purchased from a Maine dealer. They traded in an older grader with a June 2025 expiration date.
- A. Limited:** Collect the excise tax. If the unit is at or below 26,000 lbs. the transaction may be completed as a new SM. If the unit weighs in excess of 26,000 lbs. refer to a neighboring Truck town or a branch office.
 - B. New:** Same as above.
 - C. Truck:** Process this special mobile equipment with the new class (SM) of pine tree plate. Easton may retain or turn in the old TR plate.
 - D. Branch:** Verify payment of excise and process. Issue the next available pine tree class SM plate.



Scenarios

23

It is September 20, 2025. Ryan has a new air compressor truck purchased from an out of state dealer. He is here to add the unit to an existing fleet with a February 2026 expiration date.

- A. Limited:** Prorate the excise tax based on 6 months to add the new unit to a February fleet. Be sure to indicate the fleet and excise is prorated on the document. Then refer to a neighboring town authorized to process this unit type or a branch office for completion.
- B. New:** Collect the prorated excise tax. If the unit is at or below 26,000 lbs. the transaction may be completed as a new SM. If the unit weighs in excess of 26,000 lbs. refer to a neighboring Truck town or a branch office.
- C. Truck:** Process this special mobile equipment with the new class (SM) of pine tree plate. Prorate the excise and registration fee to the common expiration date of the existing fleet, February in this example. Be sure to trigger the Fleet print phrase.
- D. Branch:** Verify payment of excise and process a prorated registration fee, assigning the new SM class pine tree plate with a February 2026 expiration. Be sure to trigger the Fleet print phrase.



Scenarios

- 24** It is December 22, 2025. Allen has a new pick-up purchased from a Maine dealer. He traded in his prior car with PC plate 1715FB. He wants to register for a full year with 10,000 RVW and a NT plate.
- A. Limited:** Complete this transaction issuing the next available NT class plate. For the NPI period this is a permissible transaction at this authorization level. For manual towns, please indicate the plate change and prior plate number. Indicate the GVW as 10,000 and collect the proper registration fee associated to that GVW.
 - B. New:** Complete this transaction issuing the next available NT class plate. Indicate the plate change and prior plate number. Indicate the GVW as 10,000 and collect the proper registration fee associated to that GVW.
 - C. Truck:** Same as above.
 - D. Branch:** Verify payment of excise and process, issue the next available NT class plate.



Scenarios

25 Mason reserved her PC 1234MR plate in August of 2024 as a PC. It is December 2, 2025. She has come in to renew her registration which expired November 2025. She received the plates, and she no longer wants the PC and would prefer the NT plate: **(A)** with the reserve number 1234MR; **(B)** any number available.

A. Limited:

- A. Pull the preprint or delta file record for any notifications. Collect excise tax only and send Mason to a branch office.
- B. The reserve fee is not refundable after the plate has been received. Create a new renewal document indicating a plate change from PC 1234MR and issue the next available NT plate from inventory. Have the registrant turn in the reserved PC plate number.

B. New & Truck: Same as above.

C. Branch:

- A. Verify payment of excise. Have the registrant turn in the reserved PC plate number. Complete a MV553. Record the plate change on the registration listing the new NT plate number 1234MR and the 'Reserve# Fee Pd' print phrase and collect an additional \$25.00 reserve plate fee. Provide the appropriate month and year stickers along with the registration. The customer will operate on the expired chickadee plate until the newly reserved plate arrives. Remind the customer to hold the stickers for the new plate. Expect the plates to arrive within 2 -3 weeks.
- B. Verify excise tax. Issue the next available NT plate. The previously reserved plate may be retained for use on another appropriate vehicle for up to 1 year from original reservation date.



Points to Remember

- Rapid Renewal **is an option** for residents of participating municipalities that may not always be addressed within the scenarios.
- Pine tree plates are to be issued in conjunction with renewals, commencing with the May renewals.
- Although you may have inventory, **Pine Tree plates are not available prior to May 1, 2025.**
- Limited New Registration Agents are to exchange plates **only for the same class code and type** (like for like), with the exception of changing from PC to NT class.
- Limited New Registration and New Registration Agents **must not process or increase registered weights to exceed 26,000 pounds registered weight.**
- Limited New Registration Agents will process new registrations on licensed Maine dealer sales when the customer has an available chickadee plate that could be used.
- New registrations may only be processed, and plates issued for **transactions included within your specific authorization level.** Disabled (DX) is an example of plates that may not be issued as first-time new registrations. Specifically, this is when the registrant does not have a Disabled (DX) chickadee plate to swap out.
- General issue chickadee plates **will not be printed after March 31, 2025**, due to on-hand supplies. When the new plate issue commences, only pine tree plates will be manufactured for general issuance. However, all lost plate applications processed prior to March 31, 2025, will be honored. The plate will be ordered in the chickadee design.



Points to Remember

- Always verify the information on the reserved plate: **name, address, and expiration date**.
- Class code and plate changes are to be processed by New Registration and Truck Registration authorization levels.
- You can process most transactions, if you have the proper paperwork, if it is **within your authorization level**, or the **Administrative Office authorizes** the transaction. If authorized to process an exception, record who provided the permission.
- Check the plates – **make sure the sets contain two plates with the same number and that they are printed properly on the plate materials**.
- The old (chickadee) plate and class code **must be recorded on all registration transactions involving a plate change**.
- The stand-alone Reservation Portal allows for the reservation of a license plate number independent from the rapid-renewal process. The eligibility to use **this portal lapses approximately 1 month prior to expiration dates from May 1st, 2025, through April 2026**. Rapid Renewal, the branch offices and the Administrative Offices will continue to reserve eligible plates during the entire NPI year.
- This **information is subject to change**. Updates will follow.



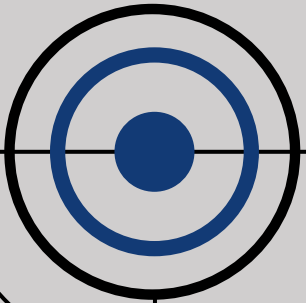
