On October 31, 2017, the Maine Labor Relations Board received a duly executed Petition for Bargaining Agent Election (MLRB Form 2A) filed pursuant to 26 M.R.S.A. § 967(2) by Traci St. Clair, a representative of Teamsters Local Union No. 340 (Teamsters). Inasmuch as the requirements set forth in the Board's Rules were met, a Bargaining Agent Election by mail ballot was scheduled to be conducted among employees in the collective bargaining unit described below, between Tuesday, May 28, 2019, and Wednesday, June 12, 2019. In accordance with Board Rule Chap. 11, § 14(2) and § 46, sample ballots and notices of the election were prepared and distributed on May 3, 2019, for both informational and posting purposes to Ms. St. Clair for the Teamsters and to Town Manager Dana Lee and Robert W. Bower, Jr., Esq., and for the Town of Eliot. On May 28, 2019, ballots were mailed to all members of the unit included in the list of eligible voters prepared by the employer.




