I. Executive Summary

The Maine Biennial Hazardous Waste Report for 2017 and 2018 has been prepared by the Maine Department of Environmental Protection (“Department”) to fulfill the requirement of 38 M.R.S. § 1319-Q(2) for biennial reporting on the generation, transportation, and handling of hazardous waste in Maine.

The Maine Biennial Hazardous Waste Report for 2017 and 2018 does not include complete data for the period of June 30, 2018 through December 31, 2018 of the 2018 reporting year. This is due to the implementation of the U.S. Environmental Protection Agency (EPA) electronic manifest system (eManifest) which became effective on June 30, 2018. Prior to June 30, 2018, hazardous waste manifests for wastes shipped from Maine-based generators or received by Maine-licensed facilities were required to be submitted to the Department. That information was entered into Maine’s manifest database and is included in this report. Since June 30, 2018, EPA has required all hazardous waste manifests to be submitted to the federal Manifest Clearing House (instead of to individual states) for data entry into EPA’s eManifest database. At the time that this report was prepared, the federal Manifest Clearing House had not completed data entry for manifests initiated during the period of June 30, 2018 through December 31, 2018. In addition, data transfer systems were not fully developed to facilitate the importation of manifest data from the eManifest system to state databases. As a result, manifest data for the June 30 to December 31, 2018 period was not available to the Department for this report. The Department is currently working with the Maine Office of Information Technology (OIT) on a system to import data from the EPA eManifest database into Maine’s manifest database. Once this data import system is complete and tested, the Department intends to import all of the data pertaining to Maine hazardous waste handlers into Maine’s manifest database for inclusion in future biennial reports.

A total of 72,565,302 pounds of hazardous waste was generated in Maine during calendar year 2017 and a total of 47,030,254 pounds of hazardous waste was generated through June 30th of calendar year 2018 (Table 1). These totals include hazardous waste generated from manufacturing and commercial activities, as well as hazardous wastes generated from clean-up/remediation projects in Maine.

A total of 70,984,649 pounds of hazardous waste was exported from Maine generators to out-of-state facilities in 2017, and a total of 45,853,456 pounds of hazardous waste was exported through June 30th of 2018 (Table 4).

Two licensed commercial hazardous waste facilities in Maine accept wastes from generators. The two facilities received 1,404,957 pounds of hazardous waste from Maine generators in 2017 and 411,000 pounds through June 30th of 2018. Additionally, 435,072 pounds of hazardous waste were imported from out-of-state generators to Maine’s two commercial hazardous waste facilities in 2017, while 41,684 pounds of hazardous waste were imported through June 30th of 2018 (Table 3).

An assessment of the hazardous waste generation trends for Maine from 1993 through 2018 indicates that yearly waste generation totals vary greatly year-to-year, primarily due to the volumes generated by site remediation projects (see Figure 5 of the report).

II. Introduction

The Maine Biennial Hazardous Waste Report for 2017 and 2018 has been prepared by the Department to fulfill the requirements of 38 M.R.S. § 1319-Q (2) for biennial reporting on the generation, transportation, and handling of hazardous waste in Maine. The requirements of 38 M.R.S. § 1319-Q(2) include biennial reporting on the following: (1) amount of hazardous waste by type generated, handled and transported in Maine; (2) the amount of hazardous waste by type handled at commercial hazardous waste facilities in Maine; (3) the number of hazardous waste facility permits by type currently active, granted and revoked; (4) the amount of hazardous waste imported from out-of-

state generators to in-state hazardous waste facilities, and the amount of hazardous waste generated in Maine exported to out-of-state facilities; (5) a list of hazardous waste facilities in Maine and out-of-state available for use by generators in Maine; and (6) a list of known firms which provide testing, consulting, brokerage, waste exchange, transportation and other services to generators in Maine.

This report includes data from shipments of hazardous waste from all facilities that generated and shipped hazardous waste using a hazardous waste manifest in 2017 and 2018. This includes facilities that are regulated in Maine's three categories of hazardous waste generators: Small Quantity Generators, Small Quantity Generator Plus, and Large Quantity Generators. Small Quantity Generators (SQGs) must generate less than 100 kilograms or 220 pounds per month and must not accumulate more than one 55-gallon drum or 440 pounds on site at any one time. SQGs have the fewest regulatory requirements. Those in the Small Quantity Generator Plus (SQG Plus) category also must generate less than 100 kilograms or 220 pounds per month, but can accumulate up to three 55-gallon drums or 600 kilograms of hazardous waste on site at any one time. SQG Plus facilities have regulatory requirements in addition to those that SQGs must adhere to. Large Quantity Generators (LQGs) generate more than 100 kilograms or 220 pounds per month or accumulate more than 600 kilograms (1,320 pounds) on site at any one time. This report also includes waste quantities from "one-time generators" of hazardous waste. Examples of one-time generation of hazardous waste include site remedial activity and underground gasoline storage tank removals.

Hazardous waste information in this report was compiled from the Department's hazardous waste manifest database. It is expected that the information for future biennial reports will be compiled from data imported to the Department's hazardous waste manifest database from EPA's eManifest system. For this 2017 and 2018 report, all facilities that ship hazardous waste, regardless of quantity, were required to submit a hazardous waste manifest to the Department until June 30, 2018. Department staff entered shipment information from the manifests into the Department's manifest database. The unit of measure used in this report for the quantity of waste is pounds. The hazardous waste quantities reported on the manifests which are not reported in pounds (i.e. gallons, liters, etc.) are converted to pounds using conversion factors based upon the type of waste. This report does not include hazardous waste generated and treated on-site under abbreviated treatment licenses since this waste is not transported or documented on manifests, is not entered into the manifest database, and is a relatively minor amount compared to the shipment data. This report also does not include information about waste oil or bio-medical waste generation or shipment. This report includes data and information on universal wastes, a category of hazardous waste. However, the data and information on universal waste is compiled and reported separately from hazardous waste and includes information on universal waste recycled under manufacturer take-back programs.

III. Waste Generation

In 2017, 72,565,302 pounds of hazardous waste and in 2018, 47,030,254 pounds of hazardous waste were generated and shipped by Maine generators (Table 1). Universal wastes, a sub-category of hazardous waste which includes fluorescent lamps, cathode ray tubes, mercury switches and other wastes, are not included in the totals reported in Tables 1 - 4 and Figures 1 - 5. Data related to the recycling efforts for universal wastes are reported and discussed in this report, on pages 11-16 and in Figures 6 - 9.

Table 1 shows the quantities of hazardous waste generation in Maine, by generator type, for calendar year 2017 and through June 30th for calendar year 2018, while Figures 1 and 2 illustrate the percentage of hazardous waste shipped by generator type for 2017 and 2018 (through June 30th), respectively. Generator types in Table 1 include: LQGs and SQG Plus; One-time Generators; and SQGs.

2017 Hazardous Waste Generation



2018 Hazardous Waste Generation




Table 2 provides, by waste types, the quantity of hazardous waste generated in pounds for 2017 and 2018. For a graphical representation of this same data, see Figures 3 and 4. It should be noted that the data in Table 2 and Figures 3 and 4 represent an approximate breakdown of hazardous waste quantities by waste types. The reason for the approximation is that many waste items can be reported under more than one waste type. For example, chemical oxygen demand test vials contain both corrosive chemicals and metals. For waste items where more than one waste code was reported, the quantity is accounted for under the first waste type listed for the waste item described on a manifest.

2017 Hazardous Waste by Waste Types




IV. Waste Generation Trends

The Department analyzed hazardous waste trends from 1993 through 2017 (2018 is excluded because data is incomplete). Two different sets of data and corresponding trend lines are plotted in the graph in Figure 5 for (1) the total amount of hazardous waste generated (all wastes including remediation waste, i.e. one-time generators or clean-ups) and for (2) manufacturing and commercial wastes generated by SQGs, SQGs Plus, and LQGs (i.e. excluding one-time generators/ remediation waste).

The upper trend line is the total amount of hazardous waste generated in Maine, which includes hazardous waste from site remediation as well as manufacturing and commercial activities. This trend varies considerably from year to year depending on the number of remediation projects underway during each year and the volume of clean-up wastes generated from such projects. For example, the peaks that occurred in 1997, 2001, 2003, 2007, 2011 and 2017 were a result of major remediation or clean-up projects. Listed below are specific remedial projects that produced significant volumes of hazardous wastes during peak years of hazardous waste generation:


For the reporting year of 2017, the remediation of mercury-contaminated soil by Mallinckrodt US LLC at the former Holtrachem site accounts for the significant increase in volume of hazardous waste in Figure 5.

The upper trend line since 1993 for the total amount of hazardous waste generated including remediation waste (upper line in Figure 5) represents a weak upward regression (correlation coefficient $r^2 = 0.0007$), with variations due primarily to the volumes generated from site remediation projects.

The lower trend line in the graph shows hazardous waste generated from manufacturing and commercial activities from 1996 through 2017, excluding site remediation wastes. Increases in hazardous waste generation from manufacturing and commercial activities occurred in 1997, 2000, 2002, 2005, 2007, 2012 and 2016, while other years during this period show waste generation from manufacturing and commercial activities either remaining steady or decreasing. During this biennial reporting period, wastes generated from manufacturing and commercial activities in 2017 showed a slight decrease from the last biennial reporting period. The trend line since 1996 for hazardous waste generated from manufacturing and commercial activities (excluding remediation projects) represents a weak

downward regression (correlation coefficient $r^2 = 0.2153$). A simple comparison of the amount of hazardous waste generated in 2017 (i.e. 6,953,048 lbs.) to that generated in 1996 (i.e. 9,548,144 lbs.) shows a decrease of approximately 27%.

V. Licenses and Abbreviated Licenses

As of December 2018, there were seventy-two (72) facilities licensed in Maine to handle, treat or store hazardous waste, including two (2) commercial storage facilities, one (1) commercial treatment and storage facility, one (1) mixed waste storage facility, two (2) post closure facilities, fifty-one (51) facilities licensed for beneficial reuse on-site, twelve (12) other facilities licensed for a variety of site-specific hazardous waste activities, and three (3) facilities licensed for de-manufacturing of universal waste. Appendix A provides a list of the facilities in Maine licensed to handle, treat or store hazardous waste.

VI. Import/Export Information

Imports

Approximately 435,072 pounds in 2017 and 41,684 pounds in 2018 of hazardous waste were imported into Maine from other states for treatment or recycling. ENPRO Services of Maine (ENPRO) in South Portland was the

receiving facility for 100% of the imported waste in 2017 and in 2018, which consisted of only one waste code type, designated as D001/D018 ignitable and benzene-contaminated hazardous waste. ENPRO, which changed its legal name to “NRC Environmental of Maine, Inc.” in February 2019, is licensed by the Department to treat D001/D018 hazardous waste, i.e. waste gasoline and oil-contaminated water, and to store hazardous waste for subsequent transport to other facilities licensed for treatment or disposal. Table 3 contains the amounts of hazardous waste (D001/D018) that were imported from other states during the reporting period. The amount of waste imported is based on the wastes that are deemed hazardous in the State of Maine and does not include waste deemed hazardous in another state or country, if that waste (i.e. waste oils) is not considered hazardous waste in Maine. However, fluctuations in the amount of imports are common, and generally have depended upon the volume of out-of-state remediation waste which is imported to ENPRO. Over several reporting periods, the amount of hazardous waste imported has not had a singular trajectory. Some years the numbers have increased, while other years have seen significant decreases in the amount of hazardous waste imported into the state. The 2018 reported numbers are only representative of data calculated up to June 30, 2018 due to EPA’s eManifest system.

Exports

Of the 72,565,302 pounds of hazardous waste generated and shipped by Maine generators in 2017, 97% (70,984,649 pounds) was exported to other states and Canada for treatment, storage, or disposal. Of the 47,030,254 pounds generated in Maine in 2018, through June 30, 2018, 97% (45,853,456 pounds) was exported to other states and Canada. For a complete breakdown of wastes exported to other states and Canada, see Table 4 below.

VII. Maine Waste Handled at Commercial Hazardous Waste Facilities in Maine

In 2017, 1,404,957 pounds of hazardous waste generated in Maine and in 2018, through June 30, 2018, 411,000 pounds of hazardous waste generated in Maine were shipped to licensed treatment or storage facilities (TSF), i.e. commercial hazardous waste facilities, within the state. ENPRO Services of Maine in South Portland received approximately 1,404,435 pounds of Maine-generated waste in 2017 and 410,585 pounds in 2018, through June 30, 2018 of Maine-generated waste consisting primarily of waste gasoline and water mixtures. Other than the gasoline-contaminated wastewater treated on-site, the remaining hazardous waste (primarily waste gasoline) received by ENPRO is ultimately sent out of state for treatment and/or disposal. Additionally, Portsmouth Naval Ship Yard, which is a licensed storage facility, authorized to receive hazardous and universal wastes from other military facilities (to store, bulk, and subsequently ship to licensed treatment or disposal facilities) received 522 pounds of hazardous waste in 2017 and in 2018 received 415 pounds of hazardous waste generated at military facilities located in Maine.

VIII. Hazardous Waste Facilities

A listing of commercial hazardous waste facilities within the United States is provided in Appendix B. The listing is from U.S. EPA's ECHO database which can be found at <http://echo.epa.gov>. The listing includes the two

commercial hazardous waste facilities in Maine which are licensed by the Department: Portsmouth Naval Shipyard in Kittery (for waste generated by military facilities); and NRC Environmental of Maine, Inc. (formerly ENPRO Services of Maine) in South Portland which treats waste gasoline and oil-contaminated wastewaters. Portsmouth Naval Shipyard can only accept hazardous waste from other military facilities. NRC Environmental of Maine, Inc. can accept hazardous waste from other generators. In addition to those two facilities, Central Maine Power's North Augusta Service Center (CMP - NASC) in Augusta is a Department-licensed hazardous waste facility for storage of PCB wastes generated off-site by CMP. CMP-NASC can only accept waste PCB generated by CMP facilities.

IX. Transporters

Maine's hazardous waste generators are required to ship their wastes using licensed hazardous waste transporters. Transport companies apply to be licensed annually by the Department. The majority of transporters are full-service entities that also provide testing, consulting, and other services associated with transportation and disposal of hazardous wastes. The Department licenses the company, the conveyances, and the conveyance operators. Driver's records are reviewed. The companies, once listed, are placed on a list of licensed transporters which is available to the public. A complete list of transporters, their site and mailing addresses, and phone numbers is supplied in Appendix C and is available on the Department's web site at <http://www.maine.gov/dep/maps-data/documents/activehaztrans.pdf>. Appendix D provides a list of firms that the Department is aware of (in addition to the licensed transporters in Appendix C) which offer services in hazardous waste testing, consulting, brokerage, waste exchange and other hazardous waste related services. Inclusion of a firm on this list does not constitute an endorsement from the Department.

X. Universal Waste

The Universal Waste category was created to encourage the proper management and recycling of certain hazardous wastes, including a number of which are widely generated by entities such as small businesses or schools. Small businesses that typically do not generate other hazardous waste may generate universal waste.

Universal wastes include mercury or lead containing lamps (Sodium Vapor, HID or fluorescent), mercury thermostats, cathode ray tubes (CRTs), non-leaking polychlorinated biphenyls (PCBs) lamp ballasts, mercury devices such as mercury thermometers and switches, mercury switches from automobiles, and certain types of batteries, such as NiCad, lithium, silver oxide, mercury oxide, and sealed lead-acid batteries (alkaline batteries do not exhibit a hazardous waste characteristic and are not included). In March of 2015, Architectural Paint was added as a universal waste category. Data on the quantities of universal waste items collected at municipally-owned central accumulation facilities, and at sites sponsored by Call2Recycle and the Thermostat Recycling Corporation (TRC), are included in this report. This data may include household waste which meets the description of universal waste, including electronic devices containing circuit boards.

Universal waste shipments are tracked by either a log system, through the use of Uniform Bills of Lading (UBOLs) or hazardous waste manifests, or reports from manufacturer take back programs. Universal waste can be collected at central accumulation facilities (company or municipally owned) and commercial consolidation facilities before being shipped to a recycling facility. Universal waste going to a recycling facility must be documented on a UBOL or hazardous waste manifest. The UBOLs, as well as manifests, are entered into the Department's manifest database. However, beginning on June 30, 2018, shipping data of universal waste documented on hazardous waste manifests was not available, due to the data entry and data transfer delays associated with the new federal eManifest system. The data on Architectural Paint for 2018 is incomplete because architectural paint waste shipped by contractors under the PaintCare Program in Maine were documented by hazardous waste manifests during the period from June 30, 2018 through December 31, 2018. Other universal waste data for 2018 may also be incomplete depending on the extent that universal waste generators had waste shipments documented by hazardous

waste manifests during the period from June 30, 2018 through December 31, 2018. At the time that this report was prepared, that information was not available from the federal eManifest system. The Department compiled the data for this report by reviewing Maine's manifest database (including UBOLE data entered through December 31, 2018), reports from the TRC and Call2Recycle manufacturer take back programs, and reports of motor vehicle mercury switch collections from the Alliance of Automobile Manufacturers, Subaru, the Truck Manufacturers Association and the Recreational Vehicle Industry Association. Figures 6, 7 and 8 show the number of items that were shipped for recycling or disposal from 2007 through 2018 in a line chart format. Figure 9 illustrates the total number of all universal waste items that have been sent for recycling for the years 2003 through 2018, excluding the Architectural Paint which has only been collected as universal waste beginning in March 2015.

The graphs show most universal waste collection is leveling off with spikes in recycling of electronic devices and CRTs from 2011 through 2014. The large spike in handling electronic devices and CRTs is attributed to e-Waste Recycling Solutions (which was a licensed electronics de-manufacturing facility until 2019) receiving over a million electronic devices and CRTs, including some from out of state handlers, in conjunction with the e-waste product stewardship program. Data regarding Architectural Paint has only been collected for two full calendar years (2016-2017), so no trend is yet apparent. The Department's annual Product Stewardship report provides additional information regarding wastes managed by manufacturer take-back programs.

2007-2018 Universal Waste Thermostats, Mercury Devices and Vehicle Mercury Switches



2007 - 2018 Universal Waste PCB Ballasts and Batteries



2007 – 2018 Universal Waste Lamps, CRTs, Electronic Devices and Architectural Paint



