Re: Surrender of Maine Medical License (Complaint No. CR14-41)

Dear Members of the Board of Licensure in Medicine:

I understand that on March 11, 2014, the Maine Board of Licensure in Medicine ("Board") reviewed information it received from me on February 24, 2014, regarding a resignation order ("Order") dated January 22, 2014 of the Commonwealth of Massachusetts. The Order referenced Adjudicatory Case No. 2014-006, and resolved that case with the voluntary resignation of my medical license in the Commonwealth of Massachusetts. In addition, the Order required me to provide the licensing boards of all states in which I held a medical license with a complete copy of the order within ten (10) days. The resignation letter stated that I would "resign any other licenses contemporaneously" with my resignation in Massachusetts and make no attempt to seek licensure elsewhere. I was delayed in providing the Maine Board with a copy of the Order. I obtained a license to practice medicine in Maine in 1998. I have never practiced medicine in Maine and on January 22, 2014 did not realize my Maine license was still active. With my awareness of my active status in Maine, a copy of the Massachusetts order was delivered to the Maine Board.

I further understand that as of March 11, 2014, I had not offered to resign my Maine medical license. As a result of that fact and following its review of the foregoing information, the Board issued a temporary "Order of Immediate Suspension" of my Maine medical license, and set the matter for an adjudicatory hearing.

In lieu of further proceedings regarding Complaint CR14-41, I hereby tender the surrender of my Maine medical license to the Board. I fully understand and agree that if the Board accepts the surrender of my Maine medical license while under investigation, that it will result in a report from the Board to the National Practitioner Data Bank (NPDB) and the Federation of State Medical Boards (FSMB) that I surrendered my Maine medical license while under investigation of an open complaint. I further understand and agree that:

1. I will not apply to reinstate my license to practice medicine in the State of Maine.
2. I will immediately offer to resign any other medical licenses that I may have in any jurisdiction.
3. I will make no attempt to seek to practice medicine in any other jurisdiction.

SCHEDULING ORDER

Complaint CR 14-41

On March 18, 2014, the Maine Board of Licensure in Medicine issued a notice of hearing indicating that an adjudicatory hearing would be held regarding Complaint CR 14-41 and the summary suspension of the Licensee's medical license on April 8, 2014. On March 27, 2014, counsel for the Licensee requested a continuance of the hearing date on the basis that counsel required additional time to adequately review the matter, including a proposed consent agreement. The parties agreed that a continuance would be premised upon the continuation of the summary suspension of Dr. Hardy until a hearing date or signature of a consent agreement. The State did not object to the continuation in those circumstances.

The continuance was granted on March 28, 2014. The summary suspension of the Licensee's medical license remains in full force and effect pending hearing or execution of a consent agreement.

The hearing in this matter is expected to take place on July 8, 2014, at 1:00. An amended notice of hearing will be issued.
