SECTION 1: FPUC – Important Information

Important Information

The purpose is to provide states with operating, financial, and reporting instructions for the FPUC program authorized by Section 2104, Emergency Increase in Unemployment Compensation Benefits of the CARES Act of 2020, Public Law (Pub. L.) 116-136. See the following informational outline:

- The FPUC program provides an additional \$600 per week to individuals who are collecting regular UC, including UCFE and UCX, and the following UC programs:
 - Pandemic Emergency Unemployment Compensation (PEUC)
 - Pandemic Unemployment Assistance (PUA)
 - Extended Benefits
 - Short-Time Compensation (STC)
 - Trade Readjustment Assistance (TUA)
 - Disaster Unemployment Assistance (DUA)
 - Payments under the Self-Employment Assistance (SEA) program
- FPUC Period is from March 27, 2020 and ending on or before July 25, 2020.
- FPUC is not payable to individuals who are receiving DWB payments.
- The system will generate the FPUC payments automatically for all eligible claimants who file a weekly claim certification and are receiving at least \$1.00 of regular unemployment insurance benefits.
- If a claimant has elected to have state and or federal taxes deducted from their regular unemployment insurance benefits, then this will also be deducted from the FPUC payment.
- The same will apply for claimants that have Child Support deductions and will be deducted from the FPUC payment.
- Individuals with Overpayments will also see deductions from the FPUC payment. Regular deductions will be made from the weekly benefit amount per existing rules. Deductions will also be made from the FPUC payment up to 25%. Example: Claimant's WBA is \$200, has \$100 overpayment, \$60 deducted from the weekly claim and the remaining \$40 would be deducted from the FPUC payment.

NOTE: FPUC Period: March 27, 2020, and ending on or before July 25, 2020.

SECTION 2: Claimant Self-Service – FPUC Inquiry Steps

This section provides the steps to take once you have logged into your ReEmployME account to view the FPUC payment details.

Step 1: From Main Menu > Select Inquiry > Benefits > Claimant / Claim Inquiry

On the subsequent screen make sure to select "File Weekly Certification" in the bottom right corner of the screen. This will load the weekly claim questions, which will have to be completed in order to file your weekly certification.
